ELECTION OF CHAIRPERSON OF COMMITTEES

Hon. Speaker: Hon. Members, I draw your attention to the provisions of Article 178 (2) of the Constitution of Kenya, which states that 'a sitting of the County Assembly shall presided over by the Speaker of the Assembly or in the absence of the Speaker, another Member of the Assembly elected by the Assembly.

Further, section 9(4), of the County Governments Act provides that, at any time in absence of the Speaker of the County Assembly or in matters that directly affect the Speaker, the County Assembly shall elect a Member to act as the Speaker as contemplated under Article 178(2)(b) of the Constitution.

Standing Order 14(1), provides that, 'as soon as practicable after the election of a Speaker, following a general election, a Chairperson of Committee shall be elected.' Further, Standing Order 14 (4), provides that, 'the procedure for electing a Chairperson of committees

shall with necessary modifications shall be the same as that prescribed for the election of the Speaker.'

Hon. Members, the Clerk of the County Assembly circulated an internal memo on 14th September, 2017, inviting interested persons to collect nomination papers for the election of the office of the Chairperson of Committees between the hours of 8 a.m. and 5 p.m. commencing on Friday, 15th September, 2017 and ending on Saturday, 16th September, 2017. You are aware that it was an internal memo because the Member to be elected is just amongst you.

Standing Order 5(2), requires that nomination papers be handed back to the clerk at least 48 hours before the time appointed and which the Assembly is to meet to elect the Chairperson of committees, that is by Sunday, 17th September, 2017 at 2.30 p.m.

Hon. Members, at the close of this period, only two candidates had picked nomination papers for election as Chairperson of Committees, namely;

- 1. Hon. Paul Nzaui Museku
- MCA Mumbuni North Ward
- 2. Hon. Johanna Munyao
- MCA Mutituni/Ngelani Ward

Hon. Members, Standing Order 8, provides that, a candidate may by written notice to the clerk, withdraw his or her name before a ballot is started and in the event of such withdrawal, the clerk shall cross out the name of that candidate off any ballot papers issued for that or any subsequent ballot.

The Clerk received a letter from Hon. Johanna Munyao on the 18th September, 2017, withdrawing his candidature from the election of Chairperson to committees.

(Applause)

The Clerk, upon the closure of the nomination period publicized, made available to all Members a list showing all qualified candidates and copies of their curriculum vitae. Standing Order 11 provides that despite the provisions of this part, there is only one candidate who has been duly nominated for election as chairperson of committees---

.....as the expiry of nomination period, that candidate shall be declared forthwith to have been elected as Chairperson of committees without any ballot or vote being required.

Hon. Members, it is my pleasure to declare that Hon. Paul Nzaui Museku has been duly elected as Chairperson of Committees---

....for the County Assembly of Machakos. Thank you, Hon. Members.

(Hon. Museku took the designated seat)

Hon. Speaker: Hon. Members, there being no other---
