Hon. Speaker: Serjeant-at-Arms, we do have quorum so can you stop the bell please. Thank you. Mr. Clerk, proceed.

COMMUNICATIONS FROM THE CHAIR

STUDENTS OF NYAANI SECONDARY SCHOOL

Hon. Speaker: Hon. Members, on communication from the Chair, let me start by appreciating the presence of the students of Nyaani secondary school and welcome them to this session and Hon. Members, they are from Wamunyu ward. Who is the member of Wamunyu ward? Hon. Mutinda, yes. It would have been good if the students found him in the House, so we will pass word to him that the students visited and you are very much happy.

Hon. Mwikali comes from that area. Thank you very much; at least they have a representation. So, we welcome them and encourage them to work hard as citizens of this nation and thank you for the teachers who thought it fit to bring them here and it is hoped that they are going to emulate some of the good examples that will be exhibited by the members here in the order of the House that is at hand so that you give them inspiration and mentorship. Karibuni.

WELCOME FROM LONG RECESS

Hon. Members, on communication from the Chair, I have a number of communications to make. I am happy to welcome you all back to this second session of this House; you have had long recess. I trust that you have rested enough, that you have the energy now to start serving the electorates

effectively and that starts by keeping time for sittings of this plenary and also of all committees and I want to give an undertaking that we all need to pull up our socks particularly on time keeping so that the hours of business are known to all of us. So let us keep time.

UNITY OF MACHAKOS COUNTY FAMILY

I reiterate that as an Assembly we need to unite as Members of the Machakos County Family--

(Applause)

I am told this County Family was born yesterday. Is it a day old, just one day old? I think it is a very vibrant baby; it has a very bright future and it will go a long way into serving the people of Machakos County, and I remind you the provisions of Article 174 of the Constitution of Kenya on the principles of devolution.

We can only discharge the mandate as required by that provision of the constitution if we are united.

PENDING BUSINESS FOR SERVICE DELIVERY

Our plate is very full. In fact, it is overflowing and just to remind you we have the Finance Bill 2017. It was tabled sometimes last year and it needs to be expedited because the County can only raise revenue by having that law in place and that is the only way that we will be able to finance the 2017/2018 budget which we are implementing. So, we really need that law in place like yesterday.

There is also the issue of the CIDP which you are well aware of, and out of the CIDP we have the Annual Development Plan for 2018/2019 and then again we have several reports that are pending before the various committees on matters of great importance to the county and those reports needs to be brought as quickly as possible top this House for confirmation.

Then you know that our county, every day, is facing challenges. The people in the county are facing challenges on daily basis that call for your intervention through service delivery. I just want to give a few examples;

- a) The need to construct bridges to link wards of Muthesya and Ndithini with Masinga Central and this needs to be done across River Tana. Also Kibauni and Katangi wards across also the River Athi.
- b) We need to construct just it is, not that we are copying Makueni county. Yesterday I partook of quite juicy mangoes and I was just in praise to God of how much blessings he has given this county. Very sweet mangoes. So, we need also to think about looking for our mangoes and dairy factories; we should have been in the lead but we are going to catch up.

(Applause)

- c) And also we need to promote the tarmacking of roads;
- d) We also need to work on employment creation; the projects that if we put up will create jobs for the youth that needs these jobs and even people in the middle age and even relatively elderly people like myself and my Hon. Mueni, we also need jobs.

- e) We need to equip the youth polytechnics and we need the ECDs in place.
- f) We need to have health centers for good health, quality health for all of us.
- g) And of course we need clean water. There are so many needs so we have to do a lot of work.

Also, let me draw your attention to various report that are pending attention by this House; we have the Auditor General's report. Remember we received three reports from the Auditor General on 8th, 22nd and 25th January, 2018. I am informing you this because as at that time we not sitting. So, when you come on board, you find that you need to discuss those reports.

- a. The report of the Auditor General is generally on the Financial Statements of Machakos County Assembly Housing Scheme Fund for the year ended 30th June, 2016;
- b. Report of the Auditor General on the Financial Statements of Machakos Water and Sewerage Company Limited for the year ended 30th June, 2016;
- c. Report of the Auditor General on the Financial Statements on the Mwala Water and Sanitation Company Limited for the year ended 30th June, 2016.

These reports are hereby now committed to the Public Accounts and Investments Committee for interrogation and for a report that must be filled in the House within three months that is in accordance with Article 229(8) of the Constitution.

Hon. Members, we also have a report of Controller of Budget; that report was served to the office of the Clerk and it has matters that pertain to the operations of the budget of this county just like for all other counties and also for the national government. That is a report that is supposed to be tabled before this House for consideration and passing of such resolutions as the House may deem fit. That is going to be done soon.

UPGRADED BIOMETRIC REGISTRATION

Hon. Members, we have a biometric registration system now in place. You remember we talked about it in the first session. Now it has been undergoing upgrade since 2017 but it is ready now. So, what is going to happen is that members will be using it both in this House and also in the committees. Why do we want it?

There are several reasons, the first one is accountability. You must be accountable for your actions as elected members; you have been given the privilege of exercising the sovereign power of the people on their behalf and you must be accountable to them. We want to know who comes to this sitting on time and who does not come at all.

We also want to know who is attending committee meetings on time and who does not attend at all. Then of course there is also the issue of keeping your records; at times you may forget to sign the books you are supposed to sigh and the of course you may find that your entitlement may also be forgotten in the process. So, this is going to be for the benefit of the public and for your benefit. You will make use of it henceforth.

ROUND-TABLE MEETING WITH AHADI TEAM

There is a round table meeting that is scheduled between members of the House and Ahadi that is planned for tomorrow the 15th February, 2018 at 11 a.m. to 1 p.m. at the Gelian hotel in Machakos. It is a function that is funded by Ahadi and it is to present a report that was carried out on

urban cities. The biggest urban cities in Kenya and we must pride ourselves, Machakos is one of them.

(Applause)

There was Eldoret, Kisumu, Machakos, Mombasa, Nairobi, Nakuru. You see we are recognized amongst the big six. Okay. So, they are going to present to you this report and it is about public delivery in urban cities. It is about good governance, it is about provision of good conditions for investment. It is about amenities such as sanitation, provision of water and roads and all these are matters that are within your mandate.

So, Hon. Members, the communication from the Chair is that you avail yourselves tomorrow 11 a.m. at Gelian Hotel. They are going to provide for whatever costs that would make you comfortable in the hotel.
