PRAYERS

Hon. Speaker: Hon. Members, I am been informed that we have a gallery here and that in the gallery we have our visitors and it is always good as we start our program we recognize them. So they are guests of the Speaker; from Embu County Assembly we have James Munyi the Deputy Clerk we welcome you Mr. Munyi from Embu County Assembly. We also have Gibson Wachia from Embu too; thank you very much Mr. Gibson. We have Ruth Mwali also from Embu, thank you very much a very good neighbour you are and then we also have our guest from Kitui County Assembly.

We have Mr. Onesmus Mwangangi, Senior administration officer; welcome very much Mr. Mwangangi my namesake and then we have John Kivui, Hansard Reporter. Welcome Yvonne, thank you we have Yvonne Lele Public Communications Officer, thank you very much Yvonne, we have Onesmus Mutua Clerk Assistant; welcome Mr. Mutua.

Then we also have another good neighbour who has been very trustful to us and has attended most of our functions from Kajiado County Assembly we have Faith Kilakoi. Faith is representing the Speaker of Kajiado County Assembly and the Clerk. She is wearing two hats and then we have from the National Government we have from the County Commissioners Offices we have Madam Rita Simeu, Assistant County Commissioner. Thank you, very much Madam.

We have Duncan Mbithi, Chief Ngomano Location; thank you Bwana Chief we are under your care thank you and then we Jackline Kangendo Assistant Chief; thank you Madam Assistant Chief and then we have Boniface Mutinda Assistant Chief Kilala thank you so much and for allowing us to sit in this venue today so we welcome our visitors and then we can start our Order of the day. Mr Clerk, proceed please.

COMMUNICATIONS FROM THE CHAIR

BUNGE MASHINANI SITTING AT KIBAUNI WARD

Hon. Speaker: Hon. Members, Ladies and Gentlemen. We appreciate that today is a special sitting in this particular forum and much as we are also having the members of the Public with us, the Speaker notes that they are in the public gallery but there will be a time when the Assembly will address them in a language that we understand. On the communication from the Chair, I welcome you all to this special seating for Bunge Mashinani.

This is a forum Hon. Members that is organized in realization of the National values and principles of Governance outlined in Article 10 of the Constitution and addition to the objects of the Constitution as set out in article 174 of the Constitution. Hon. Members, we also have a requirement under Article 196 that the business of the Assembly must be conducted in open and that we should hold our sittings both of the whole House of the committee in public for public participation and so that the also appreciate the involvement of the Assembly in legislative and other business.

On this light, Hon. Members, the Assembly resolved to hold this sitting today and this is in particular in Yatta Sub-County; sorry at Yatta Sub-County we were there on 17th of October and then we also went to Ndithini so this is the third one of us sitting outside of the Assembly.

We convened this sitting Hon. Members through Gazette Notice No. 11339 Volume 121 No. 163 and the date was 29th November, 2019 and the Gazette Notice gave notice to you Members and to the general public that today we are going to be holding our sitting and this forum and we also set out the business Hon. Members that was to be transacted in this seating.

The objectives of this sitting Hon. Members is so that the Assembly is reaching as many members of the public as possible because we appreciate not all can move to Machakos to come and listen to our business and so we come to the people when they cannot reach where we are.

The forum is also to give you an opportunity to interact with the Members on one-on-one members of the public so that then you can be able to answer their questions and so through this forum Hon., Members, it is believed that we are going to make some change in one way in the lives of the members of the public in this particular area.

MEMBERSHIP IN THE COUNTY ASSEMBLY SERVICE BOARD

Hon. Members, I have a second communication which is on membership in the County Assembly Service Board. Hon. Members, I am referring you to Section 12(1) of the County Governments Act which provides for the County Assembly Service Board and then Hon. Members, I also refer you to the composition of that Board as provided for in Section 12(3) of that Act as amended as Section 47(a) of the County Assembly Services Act 2017 and the composition includes the Speaker who is the Chair, the Vice Chair who is to be elected by the Board Members and two Members of the County Assembly; one nominated by the parties the Majority Party and then the other one by the Minority party and then we are also required to have one man and one woman to represent members of the public.

Hon. Members, pursuant to this provisions, the office of the Speaker received a communication from the Majority Party Whip Hon. Tariq Mulatya, MCA Masinga Central Ward which is dated 20th November, 2019 and he nominated Hon. Peter Mutiso to sit in the CASB. That is the communication noting that it was pursuant to a resolution of the Members of the NASA Coalition who had elected Hon. Grace Mutwiwa to sit earlier on in the CASB to represent

them and I am informed that 29 Members in that coalition appended their signatures on a list of documents which is attached to the communication that I got from the Whip

So, Hon. Members, I do congratulate Hon. Peter Joseph Mutiso as now the representative of the Majority Party in the House in the County Assembly Service Board. I wish him well. I also take this opportunity to thank Hon. Grace Mutwiwa in the time she has been serving in that board and she gave all her time and energy in the service to the Assembly and we thank her for that.

DISCUSSIONS BETWEEN CAF AND KRA ON TAXATION OF ALLOWANCES

I have another communication and this is on some discussions that have been going on between the County Assemblies Forum (CAF) and Kenya Revenue Authority (KRA) on taxation matters affecting Members of County Assemblies and the County Assemblies themselves.

Hon. Members, you appreciate that the national government is in need of money and every coin that can be raised is necessary because that is what keeps us going as a nation. So, Hon. Members, KRA has expressed desire to implement the law that is providing for taxation for per diem in particular.

It has also raised issues with CAF on withholding tax on ward offices rent; it is also raising issue on top-up on your loan and mortgage provisions. The details of those have been set out in some memoranda that we came up with when we met as CAF and the discussions are not final because we are still trying to engage KRA, SRC, CRA, CoB and other offices so that we can address the issue of taxation so that it doesn't go to make Members unable to effectively serve the public that they represent much as we also appreciate that taxation needs to be effected so that the nation has money in its accounts.

So, Hon. Members, we will continue informing you because there is another meeting that is set between CAF Executive Committee and KRA on those issues. Hon. Members, that is all about the Communication that I have for the time being and I call upon the Clerk to proceed on the Order of business.

PETITIONS

CHALLENGE ON GAZETTEMENT OF MEMBERS OF MAVOKO MUNICIPAL BOARD

Hon. Speaker: Hon. Members, under this Order, we have three petitions remember that the members of the public have a right under the Constitution to petition the Assembly on any matter that is affecting them and in exercise of that right Hon. Members, the Assembly received three petitions the first one is by Mr. Albanus Mativa and this is against the Gazette Notice No. 3633 dated 10th April, 2019 by the Governor Dr. Alfred N. Mutua, Governor Machakos County on the Kenya Gazette Notice Kenya dated 18th April, 2019 on the appointed of members of Mavoko Municipal Board.

Members, you remember that we passed a Charter that established municipalities in Machakos County and Mavoko is one of the Municipalities and the Municipalities are supposed to be administered by a board. A member of public has raised an issue on the gazetttement of members of that board. That petition is committed to Committee of Justice and Legal affairs so that it can prosecute it and bring a report to the Assembly as soon as possible.

CHALLENGE ON THE NOMINATION, APPROVAL AND APPOINTMENT OF ANTHONY K. NGUNGA AS A BOARD MEMBER OF MAVOKO MUNICIPALITY BOARD

Hon. Members, we have a second petition by the same member of public Mr. Albanus Mativa and he is challenging the nomination, approval and appointment of one Mr. Anton K Ngunga as a board member of Mavoko Municipality Board; it is still about the board for Mavoko Municipality and in the same light, the petition is committed to the committee on Justice and Legal Affairs to prosecute it and present a report to the House within the stipulated time noting that it should not be more than 60 days from the date of committing the petition.

BANKING UNION STAFF OF MACHAKOS DISTRICT COOPERATIVE UNION

The final petition is by former Banking Union staff of the Machakos District Cooperative Union. These are number of members belonged to that the union of the staff of the Machakos District Cooperative Union. Hon. Members, that again is a matter of employment and the public has right to come and seek your assistance where they feel you can assist.

So, again we are committing that petition to the same Committee on Justice and Legal Affairs to interrogate it and to present a report before the House within the time stipulated; 60 days from today. Mr. Clerk, proceed.

STATEMENTS

Hon. Speaker: Hon. Members, under this Order we have two businesses. The first one is by the Hon. Mutinda and then the second business is by the Hon. Majority Leader or one who is going to hold their brief because I know Majority Leader is not here. I just want to notify you Members that this being a special sitting because we need to communicate to public; we came to present our businesses to the public and it is important that we communicate to them in a language that they understand.

For me, I have been reading this in English but if need be, I will speak in Kiswahili and if need be I will also speak in Kikamba; I have allowed you today and only today. So, Members who are going to present business here feel free to use the language that you think you can reach members of the public on. Hon. Mutinda.

EQUIPPING HEALTH FACILITIES IN KIBAUNI AND WAMUNYU WARDS WITH ANTI-VENOM TO TREAT PATIENTS OF SNAKE BITES

Hon. Mutinda: Thank you, Madam Speaker.

Hon. Speaker Article 43(1)(a) of the Constitution of Kenya 2010 stipulates that every person has the right to the highest attainable standards of health which includes the right to healthcare services including reproductive healthcare.

Hon. Speaker, noting that cases of snake bites are very common in Machakos County and especially in Wamunyu, Kibauni, Muthetheni and Katangi Wards. Aware that snake bites have been on the rise and have been fatal because anti-venom is only at Mwala Level IV hospital which is quite a distance. Hon. Speaker, pursuant to Standing Order 41(2)(c) I wish to seek the following statement:

What the Department of Health and Emergency Services is doing to ensure that health facilities in Wamunyu and Kibauni Wards and environs are well equipped with anti-venom and trained medical personnel to treat patients of snake bites.

Thank you, Madam Speaker. On the same note as you have allowed us to communicate to the public, I wish to say that it is important that the County Government, much as we appreciate that efforts by County Governments are there---

Hon. Speaker: Hon. Mutinda, are you able to say that the statement you have brought in Kiswahili and if you have to mix it in Kikamba?

Hon. Mutinda: Ni sawa I can go in Kiswahili and Kikamba.

Madam Speaker, Sheria sehemu 43(1)(a) ya Katiba ya Kenya 2010 yasema kila mtu ako na haki ya kupewa huduma za juu za huduma ya afya ambayo inaelekezwa kwa matibabu na ata matibabu ya uzalishaji;

Madam Speaker, miao yitu ya nthi yitu niyetikilile ila twetikilile miao yitu ya mwaka wa 2010 niyetikililye andu menthwe onenthe mena aki kana menthwe me na uwo wa kukwata miao ya nthi ya wuiiti onengwa ningaliko ya amwaitu kusyaa;

Madam Speaker, nienda kumanya kuweta kana kuumwa kwa nzoka ni kwingivite kuu kwitu na kuu kwitu kwi nzoka sya mataa na ila ingi ila syi sumu mwingi na nisyithiitwe siyiuma andu thini wa kisio kya Wamunyu, Kibauni, Muthetheni, Katangi na seemu ila ingi ituthengee;

Na indi, Madam Speaker, sivilali ula wtu wi vakuvi wi kuu kwitu ni Mwala Level IV navevaa tui ni vaasa ti undumwe na ala me vau Mwala vakuvi;

Madam Speaker, nienda kumantha undu silikali witu kuvitila muvea wa uitii na maundu ala ma mbanga iteisikie undu yiendee na kwika nikenda withie niyaukilya kana niyaete yindu sya kutuiita na dawa nthini wa sivilali sya Wamunyu, Kibauni na mawityoluluko mayo nundu wa dawa sya uiiti wa nzoka nundu nzoka nisyithiitwe syi thina kwitu.

Thank you, Madam Speaker.

Hon. Speaker: Thank you. Asante Mheshimiwa Mutinda na kawaida yetu huwa tukiletewa msawaada ambaa unahu public huwa tunapea waheshimiwa nafasi ya kuongea kidogo kufanya comment kidogo sijui kama kuna Mheshimiwa anataka kongea kidogo juu ya hilo jambo. Mheshimiwa Margaret.

Hon. (Ms.) Mwikali: Thank you, Hon. Speaker. Hon. Speakerna wabunge wenzangu Statement *ino yooka yooka yi nzeo pyu nundu ithye alatwikala weuni ni tisi ...* Madam Speaker my name is Margaret Mwikali noninated by the Wiper Party and because you have allowed us to express ourselves in the language that our people that we represent understand better I wish to translate my feelings and... thank you Madam Speaker for allowing us...ni asanda nitavasyaa Madam Speaker niwatwika nesa pyu undu Kisungu kii kyookie na meli na nikituemaa saa ngi ila twi vaa kwa andu ala asomu.

Niasasyaa Mheshimiwa wa Wamunyu Mheshimiwa Thomas Mutinda niweeka nesa pyu kuete muswaada huyu kati ka Mbunge ya Masaku kitumi nundu and ala twikalaa kuu weuni andu ala twikalaa kula nzoka syisyaanaa na syianiaa na syingwaa syi kali na syi mbingi. Ithye

nitwaumiie muno nundu sivitali wathi ndwithiaa dawa ya nzoka na dweleawa undu nzoka syiaile kuiitwa.

Kwoou niasasya atii Madam Speaker, kindu kii kiyiaile uka ivinda yingi ateoila mbunge yaku yavika kuu Kibauni

(Applause)

Na ni wikie nesa vyu nundu andu ma Ng'omano, Kibauni, Ikalaasa, andu ma Miu and na vaa ala twivaa twivakuvi na atumia aa na iveti ii ila iivaa koti wa Kenya umunthi nimoona Assembly ya Masaku yukite nundu nimonie natonya na nandu memuhimu kati ka silikali hii namo no maivaa koti that why Madam Speaker nyie niasasyaa kii ndyinilea unenaa naninenaa na Kikamba nikenda kila kivet kyaumwa, kyaumiwa mwana kana musee wakyo waumwa kana kyo kyaumwa kimamntha kyathi sivitali nikiithia dawa ya sumu wa nzoka. Thank you, Madam Speaker I support this statement.

Hon. Speaker: Thank you, Hon. Margaret. Hon. Cosmus Masesi.

Hon. Masesi: Madam Speaker, *twi mbunge nithiawa ni Chairman wa Health na maundu ma uiiti nthini wa County ya Masaku Madam Speaker nienda ukathiaa muno Statement ino ya Mheshimiwa wa Wamunu twikuu kisiona kya Madam Hon. Annastacia Mutuku, Madam Speaker, ula twoona niwikite nesa ngalikoni ya malelu na ninoona andu me atanu ma kuu muno meonanya naasuvie na nimavunie*

(Applause)

Madam Speaker, *ta ni Chairman wa Health Statement ino yiasya kana dawa sya uiiti kana mundu aumwa ni nzoka sya sumu syio Matuu Level IV hospital veo voka na ndiasya no useo muno County ya Masaku tuisye oundu twika owithie ona dispensary ila syi vakuvi ve dawa ya utonya andu ila maumwa ni nzoka.*

Madam Speaker, *ithyonthe nitwisi kama sumu wa nzoka nimuthuku nundu wakuumma itina wa masaa eli ethwa ndunatonwa singano niwailite ithwa wi vandu vathuku na ukasitiwa ona kuela ukwa. Madam Speaker, Committee yakwa ila nitong'oetye yanewa wia usu nituikala nthi na Executive natuyika kwa mituki withie dawa hii nisyooka kuu itheo opamja na dawa ila ingi syakuita mauwau ala angi ta detema na mauwau ala angi me anduni kuambatya nthakamee kutheea oundu twisi kana nthakame yaambata onyatgeea kumitunga vala yiallite yitheew'a na mbesa.*

Hon. Speaker: Hon. Members of the Assembly I just want to remind you of the Standing Orders. Remember I allowed you to speak in a language that the public understands but then you

address the Speaker not the public. A time will come when I will allow you to address the public. We are in the Assembly and the Standing Orders still apply. Hon. Maitha.

Hon. Maitha: Thank you, Madam Speaker. Madam Speaker, *nienda ukayiia Mheshimiwa wa Wamunyu Mheshimiwa Mutinda nundu wauete Statement ino yaukulya silikali witu wa Masaku uthengeesye dawa sya nzoka masivitali ala mevakushi anduni nikama wisye ithia andu maitu nimakwata uiiti ula waile.*

Madam Speaker, *kuuya mbunge ni Chairman wa Justice and Legal Affairs na ningukathiia kyu kwaneenwa ni Chairman wa health kana maende mekale nthi vyamwe na silikali wa Masaku ni kenda mamanthe undu vatonyeka dawa isu ithengee andu undu vatonyeka.* Asanda, Madam Speaker.

Hon. Speaker: Hon. Ndambuki and I remind Members just be brief because am going to give as many of you as possible the opportunity but remember we are also running against time we started a little late. Hon. Ndambuki and I see today you are Majority Leader.

Hon. Ndambuki: Yes.

Hon. Speaker: If you repeat it when we go back to Machakos you will be in trouble...

Hon. Ndambuki: I am going to report for the Majority Leader he is not present

Hon. Speaker: Proceed.

Hon. Ndambuki: Thank you, Madam Speaker. Madam Speaker, *nienda kukathiia Mheshimiwa Thomas Mutinda nundu wa Statement hii waete vaa mbungeni tuneenanisye muno undu andu maitu matonya ukwata uiiti ila maumwa ni nzoka.*

Hon. Speaker: Point of order, Hon. Ndambuki. Hon. Maitha.

PROCEDURAL MOTION EXTENSION OF TIME

Hon. Maitha: Hon. Speaker, point of order under Standing Order 27 we request extension of time.

Hon. Speaker, that aware that the Standing Order 27(2) provides that the Speaker shall interrupt business at 12.30 p.m. for the morning sitting;

Aware that Standing Order 27(3) provides that the House may resolve to extend its sitting time; Aware that Standing Order 27(4) requires motion to extend moving time at least 30 minutes before the time appointed of adjournment;

Hon. Speaker, I beg to move the Motion that the House resolves to extend the sitting time until the business of today.

Thank you, Madam Speaker, and I request Hon. Michael Mutiso to second.

Hon. Speaker: Thank you, Hon. Maitha. Hon. Michael Mutiso.

Hon. M. Mutiso: Thank you, Madam Speaker. I second.

Hon. Speaker: Thank you, Hon. Members. You appreciate that he took a while to travel from our destination; is it destinations or our homes to here this was the destination where do you call where you came from. Homes it took a while we say English came through the boat or is it ship so we took a while to travel here and that is why we started late and it is proper we extend time because we must do the business that brought us here and I think you Members you are in agreement with that.

(The House resumed business as per the Order Paper)

Hon. Ndambuki, thank you.

Hon. Ndambuki: Thank you, Madam Speaker. I am much obliged. *Madam Sopeaker niinnavika kwasya oneka Wamunyu, Kibauni, Muthetheni and Katangi Wards onayo Sub-County ya Yatta na Sub-county ya Matungulu nitwisyi kana kwona nzoka mbingi kwo onaku Madam Speaker nikulya Department ya Health ikasisya kati ka kila Ward sivitali ila inaabatililwe kiwango syawika Level IIIs sythiwe na dawa sya anti-venom nikana andu maitu matonye ukwata mauiiti incase maumwa ni nzoka vakuvye. Asante.*

Hon. Speaker: Thank you, Hon. Ndambuki. Hon. Mitaa

Hon. Mitaa: Thank you, Hon. Speaker. *Niambiia naakutungia Mheshimiwa Mutinda, Thomas Mutinda muvea nundu wa kwithiwa niwaete statement kana unenanisyo yiulu wa uiiti wa ala maumwa ni nzoka. Madam Speaker, ndiasya no undu wausenya kuma ila devolution syambiie kana silikali mutiuuko kindu kimwe kyaetiwe silikalini sya mutiuuko ni uiiti na kuma ivinda yiu nitwailite ithwa silikali ila syithiitwe syakwatie kindu kyu na vinya Madam Speaker nundu wa kwithiwa nisyo syatheeie kula kwi mwene nthi, Madam Speaker.*

Ndyasya onakutwikana twiaselee Madam Speaker nditya wekeo kwa andu maitu ala methiitwe manyamawa ni mawonzu mauthukumi kati wa silikali sya mutiuuko Madam Speaker Nundu wa kumbiwithya moyo nundu wakwithiwa umunthi Mheshimiwa Mutinda niwaete msawaada uso na ninisi nuunengane uendee mbee.

Hon. Speaker: Thank you, Hon. Mitaa. Hon. Annastaciah.

Hon. (Ms.) Mutuku: Thank you, Hon. Speaker. I am representing these great people you are seeing here. For the Hon. Members who are present today welcome to Kibauni. Hon. Speaker I stand to support the statement *ii yetiwe ni Mheshimiwa Mutinda*. I think Kibauni, Wamunyu, Hon. Speaker, Muthetheni *kwithaa na thina mwingi muno wa nzoka na nitwithiitwe twi loose so many lives nundu wa kwithiwa mbee accessibility ya facilities its a bit challenge na Hon. Speaker you have seen the distance from here to Mwala hospital.*

Andu ma kuu maumwa ni nzoka matwaawa Mwala nundu ithye ona dispensary hii umyona vaa ndina dawa na also twina fridge ya County Government kwitha itonya kwika dawa vo nivailite ithwa vena fridge syo preserve dawa isu twina Ikalaasa, twina Katulani na Hon. Speaker niurequest kwa ndaia because I know you are always interacting with the County Government we request your support nundu wa kwithiwa andu aa makwa nimauniite muno vyo ningulya kwa ndaia Katulani nundu niyiendee nakwikwa renovation yiupgradiwe na iyikiwa dawa sya nzoka na sya ngiti.

Kwoou kwa ndaia syonthe Hon. Speakar niukulya kwisila o mbungeni ingi statement ino upush kati ka implementation committee nikana Kibauni, Wamunyu na Muthetheni twithe twina sivitali tutonya ku-access dawa sya nzoka kana tutonya ukwata dawa sya nzoka o kwa mituki uketha mathayu ma andu nimaokoa ndineena kidogo nundu no nisi masaa ni manini ve kiveti kana kanakwie tukasyaiisyne na kanaumiwe ni nzoka na kuma ku mashinani kuetwe soko inatake two hours nundu wa poor network na kitambo kese utwawa Kalawa nundu nikwo kwi kavaa oue eighbours vaya Makueni kana ku kanakuiie nziani it was very sad story so Hon. Speaker nitunga muvea muno kwa motion isu na ndiia andu makwa kwa ndaia twiyumisyei kuma umunthi Mbunge ya Masaku niyaete kwisila Mheshiwa wa Wamunyu niwaete motion isu na Speaker witu nimwene ni kiveti ya Hon. Members na iveti syi tei na niweew'a undu vailye Hon. Speaker with all due respect eka niambe o kuneena nandu aa makwa o vanini nkana mewe kana inya ee vaa naku wi vaa.

Hon. Speaker: Hon. Annastacia, you talk to me not to them. Remember I said we are going to have a forum where we will seat with them when we are not having the Mace; when we are not having this, we will sit down with the people and talk.

Hon. (Ms.) Mutuku: Okay. Thank you, Hon. Speaker. *Kwoou kwa ndaia syonthe Mheshimiwa Speaker nyie ni support motion isu fully na ngikala nthi ngiia andu makwa nithaa nthini wa committee ya House Panel nithaa nthini wa committee ya House Business nithaa still nthini wa committee ya Health na Chairman wakwa twinake vaa nimwew'a ayineenia. Kindu kyu nikiusuviwa na niasya ndikala nthi kwa ndaia* I support the motion. Thank you

Hon. Speaker: Thank you. Hon. Members, allow me to commit the Statement to the committee on Health and Emergency Services; Hon. Masesi, you see the need to expedite this consideration of the matter in the Statement; you see the need to engage the executive immediately and you see the need to bring a report to this House and more so, the need to follow up on implementation of the resolution. Thank you, Hon...Sorry Mr. Clerk please, proceed.

I just want to correct Hon. Members under Statements which is Order No. 7, I indicated that there were two Statements. I have just noted that the second one is not a Statement but a procedural motion by the Hon. Majority Leader through the Hon. Ndambuki so we are not yet there. I have not yet pointed you to wake up so Bw. Clerk called Order No. 8 on Procedural Motion and as I have indicated, it is supposed to be prosecuted by the Hon. Majority Leader who is not here but he has an able representative in the name of Hon. Margaret.

PROCEDURAL MOTION

SHORTENING OF TIME FOR INTRODUCTION OF THE MACHAKOS COUNTY FINANCE BILL NO. 7 OF 2019 FROM SEVEN DAYS AS STATED IN STANDING ORDER 116 TO THREE DAYS

Hon. (Ms.) Mwikali: Thank you, Hon. Speaker.

Hon. Speaker, aware that the Article 185(1) of the Constitution of Kenya 2010 provides that the legislative authority of a County is vested in and exercised by its County Assembly;

Noting that the County Finance Bill No. 7 of 2019 was published on 2nd December, 2019;

Aware that the Standing Order 116 requires that a revenue Bill on Publication should be allowed in the House after seven days aware that seven days will lapse on 9th December, 2019;

Aware that the House will take long recess of the December holiday on 4th December 2019 aware that the deal can be considered for public participation over the recess and enacted at the earliest time possible as the bill is late for approval;

Hon. Speaker, I wish to move the motion that this House shortens the time for the introduction of Machakos County Finance Bill No. 7 of 2019 from seven days as stated in the Standing Order 116 to three days to ensure the Bill is approved in time.

Thank you Hon. Speaker.

Hon. Speaker: Thank you, Hon. Margaret do you have a Member to second your motion?

Hon. (Ms.) Mwikali: Thank you, Hon. Speaker. I call upon Hon. Dominic to second my motion.

Hon. Speaker: Thank you. Hon. Dominic Ndambuki.

Hon. Ndambuki: Thank you, Hon. Speaker. I second.

Hon. Speaker: Thank you very much. Hon. Members you have been referred to provisions of Standing Order 116 on publication of a Bill and you notice that this motion is seeking that you shorten the period from the time provided of seven days because you remember we received the Bill late and so the processing of it is urgent because it is the one that is going to guide local revenue in the County. Hon. Members, do we have any Member who wishes to comment on this the motion; any Member who wishes to comment on this motion? Hon. Cosmus Masesi.

Hon. Masesi: Thank you, Madam Speaker. Hon. Kieti: Thank you, Hon. Speaker. I am chairman Trade, Industrialization and Economic Planning. Madam Speaker, nataka kusema hivi; Finance Bill *ino niyo itunengaa utonyi inengaa* County *uonyi wakwosanya koti kuma vala ve mwene nthi kuanana undu mwenzangu Mheshimiwa Cosmus Masesi waasya na ivinda ivitu niasya* Executive *nimanalikile isioni nimanaendie kila Ward mosete mawoni ma mwene nthi na nienda ukulya nundu nitwonete ivinda ivitu tuyuka tukosa mawoni ma mwene nthi yiulu wa koti ula mailekuiva na itina kila twavitukithya ta Mbunge kiilea kuatiwa uyithia andu aya maendeea akuni ma viasala maendeea na kuivithwa mbesa mbingi kuituka ila twavitukithisye kwou nienda ukulya Finance Bill *ino otodonu twaweta mithenya tukuvivye nikenda tuvitukithye na twamina uvitukithya tuikulya* Executive *yiatiee mawoni ala twikumya kwa mwene nthi na undu twivitithya kimbunge nikenda mwene nthi withie ndekuivithywa koti kuvituka. Hon. Speaker: Hon. Members, procedurally let me just let me propose the question that this House shortens the time for introduction of the Machakos County finance Bill number 7 of 2019 from 7 days as stated in Standing Order 116 to three days to ensure that the Bill is approved within time. So, Hon. Members we can continue having your comments on the matter. Hon. Kalumu.

Hon. Kalumu: Thank you, Madam Speaker. I think nikona shida sana ya Kiswahili na Kikamba lakini nitajaribu sababu tumekuja kwa wananchi. Hon. Speaker: Thank you, Hon. Kalumu Francis. Hon. Dan Mbevi.

Hon. Mbevi: Thank you, Madam Speaker. *Nienda kwasya mbee nimuvea munene muno kwa Speaker witu nundu wa isuanio yii wasuanie ya kulilikana mwene nthi nundu kii twikwika vaa umunthi kikawa Masaku ungu wa Speaker witu vai vandu vangi kikawa kana ve vandu vangi mwaakyona. Ve vandu mwaakiw'a maisha menyu?*

Hon. Speaker: Hon. Mbevi, address the Speaker.

Hon. Mbevi: Asanti.

Hon. Speaker: Actually, Hon. Mbevi, look at me look at me and address me.

Hon. Mbevi: *Kwou kila ngwenda kwasya ni ku-support motion yo umunthi ya kwongeleela ivinda ya bill ino nundu oundu kuola ivinda nundu oundu aheshimiwa ala angi maneena maasya yitha ne kutula mwiao na silikali ya Masaku itekuatiia mwiao tutena bill hii ivitukithitwe na nundu inaetiwe yi nzelee tikaema ukuvivya yi vinda tumivitukithithya ivinda yila itaile kwitha yiivitukithwa noyisa ithia nitweetha twatula mwiao kwou ningusupport mithenya ino yume muonza yuke itatu. Asanti Madam Speaker.*

Hon. Speaker: Thank you, Hon. Mbevi. Hon. Kisini.

Hon. Kisini: Asanda Madam Speaker nundu waunenga mwanya uu. Madam Speaker, niukilaa onineene ndeto niunge mukono tukuvivye kuma matuku muonza tuke matuku atatu nundu wasisya itumi ila inengetwe vaa umunthi twi matuku atano na matuku keenda matiala ovanini mathele.

Hon. Speaker: Today is 4th or 5th; what is the date today? It is 4th. Proceed.

Hon. Kisini: *Umunthi ni matuku ana lakini wasisya matuku nimaendete kwa okuvi nitangwedaa asya matuku nimaendete na nimeuthela niole kuma matuku muonza nuke matuku asu atatu meiwe nikana tuikasindwe ni ivinda nikwithwa ninoona vayiwa ovaa kana mbunge niikui kithumuoni nikana wiseithia tuinesa ithwa na ivinda ya kwaiwa kwosa koti vate mwiao. Asanda.*

Hon. Speaker: Thank you, Hon. Kisini. Hon. Mutinda.

Hon. Mutinda: Asanti, Madam Speaker. Wamunyu no vaa mutui wenyu eka nasye nienda u-support mithenya isu yiolwwe kuma muonza yuke itatu nikenda tukune wia uu kwa mituki nundu wasyisya kiserekali mwaka waambia mwai wa mbee twathi uvika mwai wa katatu matuku miongo itatu na yimwe permit ila syithaa iyendeka nisyithaa iyenda koti vaini nundu wa kwitha andu nimaselewa.

Kwoou yithaa yi useo muno kwa Assembly ino yitu twithe nitweekasa nikenda tunenge andu na serekali document ino matuku ma mwaka uu utemuthelu nikenda kuma matuku atatu kuthi ou withe andu me tayari kuiva koti mataneethiwa ni vaini naindi ndyasya niaysia niwisi na andu maitu nimesi kana ithye ta Asssembly ila twoka kwaa niwo medhwaa maele eti mawoni moo twowanye vamwe.

Madam Speaker eka nasye noonaa niendete ngew'a mundu ambia koti uu wii vinya kyau lakini nienda kumea moko tuoanye vamwe koti ula mekuivwa ila twikwithwa tuendete round nekenda withie nimekuiva koti umavikya onengwa ni munini waandu aingi na kila kikwendeka ni silikali kiyuka nikenda tutonye ukwata mbesa sya unenga andu maendeeo Madam Speaker nivika vau ni asanti.

Hon. Speaker: Thank you, Hon. Mutinda. You have brought up the issue of public participation on the Bill that we are going to prosecute and that is very important; we will be going back to the public to get their views. Thank you. Hon. Annastaaciah.

Hon. (Ms.) Mutuku: Thank you, Hon. Speaker, niungama ni-support Bill ino nundu ni nzeo na yooka ivinda yila yialite na nikulya ou matuku asu matialite withie nitwasembanya namo withie niyooka mashinani na kila kingi Hon. Hon. Speaker: Thank you, Hon. Members. I call upon the mover of the motion to reply. Hon. Margaret

Hon. Speaker: Hon. Members, under this business, I call upon the Chair for Finance and Revenue Collection Committee or his representative because I do not see the Chair whom I know very well. Hon. Phoebe Koki, representing the Chair Finance and Revenue Collection Committee.

Hon. (Ms.) P. Koki: Thank you, Madam Speaker. Madam Speaker, pursuant to Standing Order 119 I wish to table the Machakos County Finance Bill 2019 in this Hon. House for the first reading. Thank you, Madam Speaker.

Hon. Speaker: Thank you, Hon. Phoebe Koki.

(Order for First Reading read - Read the First Time and ordered to be referred to the relevant Sectoral Committee)

Hon. Phoebe Koki, you held the brief you still need to hold the brief and inform the Hon. Chair of the Finance and Revenue Collection Committee to expedite processing of that Bill because we appreciate it is urgent. Thank you, Hon. Phoebe Koki. Mr. Clerk, proceed.

MOTION

REBUILDING, DE-SILTING AND FENCING EXISTING DAMS IN KIBAUNI WARD AND ALL OTHER WARDS OF MACHAKOS COUNTY

Hon. Speaker: Hon. Members, under this Order, we have one motion by Hon. Annastacia Mutuku MCA Kibauni Ward.

Hon. (Ms.) Mutuku: Thank you, Hon. Speaker.

Hon. Speaker that aware that Fourth Schedule of Constitution of Kenya 2010 talks of County Government with matters of water and sanitation services; Aware that mission of the department of Water and Irrigation as per the County Annual Development Plan Financial Year 2019-2020 is contributed to County

Development by promoting and supporting water resource management to enhance safe water availability and accessibility for all;

Further aware that Machakos County has approximately 350 existing dams which provide water to the residents;

Acknowledging that most of these dams are especially Endau, Kasengela, Kwa Matinga dams in Kibauni Ward are at risk of drying up due to silting;

Hon. Speaker, aware that with the dams lack fence and chances of pollution are high;

Aware that these unfenced dams are a health hazard to both of human beings and animals and also noting in that Mumbuni dam project is mega (??) dam whose capacity can supply a very large area is articulated;

Aware that order for this dam to be beneficial to the residents of the Ward there is need to pump and reticulate the water;

Hon. Speaker, I wish to move the motion that the County Government of Machakos:

1. Reduilds, de-silts and fences all the existing dams in Kibauni Ward and all other wards of Machakos County.
2. Reticulates water of all existing dams to the benefit of the residents.
3. Plants trees around the dams and along the catchment area to increase forest cover and hold soil.

Thank you, Hon. Speaker.

Hon. Speaker: Thank you, Hon. Annastacia Mutuku. Seconder of your motion

Hon. (Ms.) Mutuku: I call upon Hon. Caroline to second my motion

Hon. Speaker: Hon. Caroline is also Hon. Phoebe Koki. Hon. Phoebe Koki also Hon. Carol.

Hon. (Ms.) P. Koki: Thank you, Madam Speaker. Officially, I am Phoebe Koki a special elect member by the Government Party Maendeleo Chap Chap. I second the motion.

Hon. Speaker: Thank you, Hon. Phoebe Koki.

(Question proposed)

Hon. Members, I invite you to debate the motion. Hon. Kituku.

Hon. Kituku: Thank you, Madam Speaker. Naunga mkono mjadala ambao umeletwa mbele na Mheshimiwa Annastacia sababu mabwawa yetu mengi hayajaweza kuwekwa *fence* na unapata kama si wanyama, binandamu wanachota maji moja kwa moja ama *direct* kwa hizi *dams* na imechangia sana katika kachafua maji. Unapata maji sio safi kwasababu hakujawekwa ua ama *fence*. Kwa hivo ninaomba serikali yetu ya County iweze kuzingatia kueka *fence* katika hizo *dams* zetu zote na pia kuna hizi *dams* ambazo ni kubwa ambazo maji yanaweza vurutwa zipeleke

maji sehemu mbalimbali ndiposa wananchi waweze kupata maji mahali ambapo ni karibu sana kwao.

Ama tuseme *water point* badala ya wanyama ama binadamu kuchota maji *direct* kwa hizo *dams* kuwe na mahali ambapo binadamu wanaweza ama wanyama wanaweza kunywa maji badala ya kuingia ndani. Pia miti ikipandwa huko kwa sehemu hizo ambazo tunazitaja ni kwamba miti itaweza kuzuia *evaporation*. Madam Speaker, mjadala usu kana motion isu ni nzeo ya kuseuvya dam ila nisyo inengete andu kiwu na nyamu kana indo syitu kana indo ya ene nthi ala me kisioni.*

Hon. Maitha: Thank you, Madam Speaker. Madam Speaker, *otondu naisye nitawa mheshimiwa Moffat Maitha wa kuya Matungulu West. Ndiunga mukono motion ino yaetwe ni Mheshimiwa Annastaciah Mutuku nundu wa County Government yike maundu aa makulitwe kuvukua masilanga, kwikia wiio nakuvanda miti.*

Madam Speaker, *ninisi thina ula withwaa kisioni kii wa kiwu nundu miaka yi vaaya mbeange nasomethasya sukulu wa Lema Primary ni Deputy Headmaster na nonavakene Lema na kuu noundu umwe ninoookaa kuu tukona thina ula wikwo. Madam Speaker, ila tuneewie kuu Kibauni ve silanga ya Million vakuvi miongo muonza ineziwe nituneewie moyo nundu silanga isu yenzwa na kiwu yeekiwa ikanenga andu na kuu wise ithia nimauma thinani usu wa kiwu. Kila naile ukulya silikali nene ino yitu ya county ni tuenda value ya mbesa ithwa kindu ni kya milioni miongo muonza twavika vau twasisya ou twone million miong yiana miongo muonza tuteasya ni million miongo muonza nawavika uyithia na kaindo kailye kindu kitaile.*

Kila kingi Madam Speaker ningwenda nongeleele vinya nasye silanga syonthe ila mbinze nisyaille uvukua kila kona yonthe ya Masaku nundu andu mena thina wa kiwu na maisyoka silikali ivande miti neyosa iyia nikenda wise ithia mundu ndeulikila okila vandu vonthe ukwenda nikenda silanga isu sikeata isuviwe, Madam Speaker.

Madam Speaker, ndililikana ila nai MP wa Kangundo ninenziwe silanga munene ni Mheshimiwa Katuku ila wai Minister wa water na silanga isu niyaakiwe nayoka yaiiwa vaati nthuku niiyooke ya vadaliiziwa u wiio wavetangwa ningukulya andu nenyu mwithe mwi andu makusuvia syindu mwoona yeekiwa wiio muketha ninwe metho ma kila mundu. Mwona mundu ukwika nai tokunya waya isu muirepoti kwa chief nikenda action ikosywa nikenda withie nitwasuvia masilanga asu.

Madam Speaker, kwi kundu kuuya kwitu kwenziwe masilanga ni settlers ala maikwo kuya Matungulu West kwai ma-settler maingi muno na kwi masilanga manene ona ithye tuteenda kwinziwa twikita enda mavukue kiwu kiipipiwa kinengwe andu kwoou ningukulya silikali ya Masaku na Governor witu ula tumwendete ose mwanya usu alike kila wodi yonthe vala ukwithia ve masilanga vandu va kwambainza angi ambeusuvia asu na kula kutemasilanga ayinza ndovoi nikenda andu maitu makwate kiwu koou Mheshimiwa Annastaciah niweka nesa nundu waulilikana kii nundu wa thina wa andu ma Kibauni na andu na Masaku on the. Ni asanda Madam Speaker.

Hon. Speaker: Thank you. Hon. Maitha. Hon. Dominic Ndambuki.

Hon. Ndambuki: Thank you, Madam Speaker. Nitawa Dominic Mulwa Ndambuki MCA wa Kathaini Central Ward na Madam Speaker *nienda utungia Mheshimiwa Annastacia Mutuku muvea nundu wa kuete motion ino nzeo ya kiwu* Madam Speaker His Excellency Dr. Alfred Mutua *asayaa kiwu ni haki ya kila mundu natipriviledge na* Madam Speaker *niwo kana kiwu ni thayu nanienda utungia Mheshimiwa muvea nundu niwona wailu wa kana dams ila existing* Madam Speaker *akulye silikali ya county ya Masaku yitonye kwilia yu kwilia kuu* Madam Speaker *tukusiie ikwu mbingi sya andu maitu na umunthi kamemeni nikatangaasa kana Kenya yonthe andu nitamakwie vakuvi maana atatu ni mbua ino yivo.*

Isioni okwitu nomakwie amwe nimauthi makasovoka o silangani hii matasyene na ikaiyiiwa asa ila kweethwa nakiwu kingi andu maitu nitumasiiania na mbbanga hii Madam Speaker na ingi Madam Speaker twina ila tusiitaa sustainable development goals na imwe nikana twithwe na access ya safe drinking water Madam Speaker, na twambiisya kukusya kiwu tutwaie andu maitu vala mai kwongelekanyo kengwa ni silanga ila ya Mumbuni tuendee nakwinza kuu Kibauni Madam Speaker, yiikusiw'a andu kila utui uyisa ithia nivatwa kiwu vakuvi na andu maitu twiitha tuendee na kuthengee kwiania kana wianiu wa sustainable development goals ila ndunia yonthe yiendee nakuatiia, Madam Speaker.

Na ingi nienda ukulya silikali ya County ya Masaku Madam Speaker through department ya water yu sisya andu maitu ma County ya Masaku atleast kila utui Madam Speaker County imanye kana andu maitu nimeethwa na access to safe drinking water for safe domestic use. Asanti, Madam Speaker.

Hon. Speaker: Thank you, Hon. Ndambuki. Hon. Daniel Mbevi.

Hon. Mbevi: *Oingi kwa masiyitwa nitawa Daniel Mutuku Mbevi MCA Mlolongo Syokimau Ward. Thank you, Madam Speaker again for giving me this opportunity. Kila ngwenda kwasya ni ku-support oundu aheshimiwa maitu maasya. Vai maana na silanga ingi kwinzwa kuu kwitu masaku twina silanga already enough kila kinkwendeka ni kwinzwa ilike na iyikiwa pipes ukesa kwithia silanga umwe niuse serve mautui ta atano o silanga umwe. Wimwinze nesa ukalikwa naukethia ni nzia ila yi laisi vyu itonya kungwa yi of economic use na secure kwa ananchi maitu ma Masaku nundu yiimwe kumi-treat nilaisi.*

Kumikia dawa wise kwithia kiwu kyu kiyithwa kina kichamadhara kwa andu maitu nikwithia imwe yi nene nikutreatiwa nesa nayipipiwa kutwaa kundu kula knungi kwa andu maitu ukethe kila utui wianavandu ta kioski kina kiwu kiite kitatonya uwasya andu maitu ona kiu Madam Speaker kyongeleewe nikwithwa kikekika nzoka hii syumaa andu aingi muno iveti hii syitu syumite kuta kiwu kuu utuku niwo kana tiwo kwoou kila ngenda kwasya Madam Speaker

Hon. Speaker: Are you asking me to respond? If you are addressing me, do I tell you yes or no? Proceed.

Hon. Mbevi: *Kwouu nienda kwasya kiu kyeethiwa na kiwu kyaetwe vakuvi na andu maitu nzoka isu imama nundu mundu muthenya kiwu kivakuvi ithi aute oumituki.*

Hon. Speaker: Point of order from Hon. Maitha.

(Hon. (Ms.) Mutuku crossed the floor without bowing)

Hon. Maitha: Madam Speaker, is it in order Hon. Annastacia Mutuku to walk across the Speaker's desk without bowing.

Hon. Speaker: Hon. Maitha, I did not notice that and because I did not notice that let us continue

(Laughter)

Hon. Mbevi: Thank you, Madam Speaker. *Pole kwa kusumbua; ovanini nikana nimine twinze silanga oimwe kana oilasyivo twikie dawa natuyinza silike nikana twithe na kiwu kitheu. Kila kya mwiso ngwenda kwasya ni ukwiia kwi maana muno ve uncle wakwa twi Ilovi Madam Speaker watindia umbia emantha mbesa akwe ndakenuke akanyusanie kiwu na ngiti kwou that means ngiti nisyiaccessia silanga ithi kunywaa sindu ingi nthuku tutasyisyi ukesa kwithia kiwu kina kiko kwoou nuseo ikafensiwa nikenda wisye kuthia ngiti na nyamu ila ingi nthuku itoonya ulika kiwoni kya andu maitu nikana withie maitonya uwaw'a nikiwu. Hon. Speaker: Thank you, Hon. Daniel Mbevi. Hon. Cosmas Masesi; I will come to you Hon. Members and each of you will say something

Hon. Masesi: Thank you, Madam Speaker. Madam Speaker, muyumbe musakue wa Matungulu North kana umiloni wa sua. Madam Speaker, *nookila ndungie muv a mhesima wa kisio kii Annastacia nundu wakuete motion ii mbunge nakwitha na andu ma Kibauni Ward Madam Speaker ngooni yake.*

Madam Speaker, *nasyisa motion isu neethia andu ma Kibauni me vaati mbingi muno nundu mena dam saidi wa thanthatu nthini wa Ward imwe, Madam Speaker. Madam Speaker, kii kyonekana meona masakuite mutongoi museo na indi Madam Speaker nimakulya maedee nakwika ou. Madam Speaker, Mhesimiwa asya kana dam ya Endau na Kasengela syukite ulindika nakithwa kikindu kithuku oyu kwi mbua ukethia ai mbua yathela itina wa miai ili itatu kuina kiwu nthini wa dam isu kwou ningwata kwoko muno vyu tuvukue dam ila twinasyo ila ilindikite na indi na department ya water Masaku ndisisya withie niya protect dam isu nundu onasyo syiondiku nomuisyo kwa mwene nthi.*

Madam Speaker, *oyu mituki tunaina motion inai mbunge yiulu wa kwanangwa kivu kitu nthini wa mbusi syitu kana pollution of the waters nthini wa mbusi ila syumite counties ila ingi ikesila kwitu ta Athi River na indi ngulya County yiyyutu yiendee nausiea kwanangwa kwa kiwu unduvatonyeka nundu wa kwaithwaa ene nthi aa matumia kiwu kiuu kuvanda sukuma, ngombe nosyo inyusaa, nosyokitumiawa ona misyini. Madam Speaker, koou nikulya ta mbunge ya Masaku tuendee nakungama vandu va mwene nthi nundu wakwithwa nutusakuite tumake sure andu aa makwata kiwu kila kitheu vyu.*

Madam Speaker, *ndimina Mhesimiwa ingi niwasya tiendee nauvanda miti na nouseo nundu musungu aisye watema muti umwe ukavanda ili kwou ngulywa mwene nthi Madam*

Speaker ma kisio kii maendee na uvanda miti kwa wingi withe nitwasuvia ienvironment na indi Madam Speaker ninithwaa nisi environment yinzeo na maundu ala angi nimaseuva natunga muvea muno kwa mheshimiwa nundu wa kuete motion isu nimikwata kwoko Madam Speaker yiana kwa yiana.

Hon. Speaker: Thank you, Hon. Cosmus. Hon. Mwikali.

Hon. (Ms.) Mwikali: Asanti Madam Speaker nundu waunenga mwanya huu nyie nitawa Margaret Mwikali ninyuvitwe ni kyama ngaungaamiie mbunge nithwe kindu kya kwongeleela aka ala me mbunge na tanimudu muka ninyuvitwe niende mbunge nineenee mavata ma iveti niw'a myo pyu nundu wa mwaiitu wa mwaitu mheshimiwa Annastaciah nund u wa kuete muswaada uyu wa muhimu kwa kila mundu muka onaeka Masaku Kenya.

Thina waa mundu muka wa Masaku Mheshimiwa Speaker no umwe kati ka Kenya na muno muno kuu kwitu sanasana aa twikalaa weuni. Weuni nimini Mwala, Mainga na Yatta. Kwou Madam Speaker tuthinaa muno mundu muka kana kasyawa kaenda kwanangiwa usini nundu kethethwaa kamanthite kiwu nundu kiwu niwo wia wa mundu muka.

Kwoou ndiutungia Annaastaciah muvea nundu wa kuete kindu kii kikwitwa kisuvie kiwu kila twinakyo silikali tuminenge mwanya natambunge ya Masaku mheshimiwa Speaker ithye nitwisi county yitu ya Masaku vala tuvikite yiulu wa kiwu onatuikwenda uvo wa ndovoi nundu ndovoi ngombe iinyusaa nyamu inyusaa ndovoini nikulya uvo wa silanga ndu silangi nivo kila mundu wa sirikali ala mena nduuka, indo syitu syindu syitu syoonthe tienda vau nikana nasyo silanga isu syasyeuvya kiwu ona mauwau maingi muno Speaker ala ithye tuwaa twawaaw'a nundu twina kiwu natiwaa nundu tunyusaa kiwu kila twakomana nakyo onaithwa kiilye ata.

Therefore, Madam Speaker, I stand here as a woman of peace from great County of Machakos ndyasya kana iveti nundu onasyo niinyuva kuya nthini iveti ithinaa muno nasikiawa kuuya ndeto ya Kikamba ila nzeo Mheshimiwa Iveti.... vaaya yiendete usini Madam Speaker niwoo muno vyu nundu twana tuilea kutuma twilitu twitu twende tukaute kiwu lakini ila twasiia silanga syitu natwasyumya kithangathi nakusyumwa mutondo twithaa twasuvia syana syitu naitu tuikekiwa ali kuu Madam Speaker nikenda wise kwithia nao nthi yitu niyaseuva kwoou na tuinyuva atongoi tumanyuva mwatwatha kiwu na mathi maithi imwe so county Government of Machakos nimekututetheesya muno ila mekwinza silanga maseuvye kiwu naitu nitwikumila natuimatetheesya kuvanda miti asanti sana. Hon. Speaker, I support.

(Applause)

Hon. Speaker: Thank you, Hon. Mwikali. I am just coming down so we start with Hon. Mutinda

Hon. Mutinda: Thank you, Hon. Speaker. Madam Speaker eka nasye ittunge muvea kwa mheshimiwa Annastacia Mutuku nundu wa Motion ino nzeo nandyasya ningumiunga mukono na ndyasya Madam Speaker twi ivinda iseo muno ya motion ino ila yooka nundu oyu mituki twiiketye uvo wa waukulanya uvo wa kiwu kwa Athi ukamba witu wa Masaku ila Athi yina kiwu tene niyoinantutethasya lakini yina Kiwu lakini kiwu kyanange.

Madam Speaker nayu ni ivunda twaile umanthe undu twaile umantha undu tusyeuvya syiwi syitu kuu masilangani nikenda withie twina syiwu syaututwaa ivinda ya thano Madam Speaker tumite ivinda kwi thano thano munene masilanga mangala na kuvimuvango muna kana

muvango museo woondu masilanga asu meuvukuika niketha kwakwa Wamunyu nikuniawa simu ni andu ma ndua ana na ndua ana maimbia yu silanga witu wingalile nduke utwinzie ngamea thina wa mbesa niwalikile Ilovi lakini mwene nthi koukwenda kwiw'a ou mwene nthi enda kwona silanga wimwinze kwou Madam Speaker kila twikwenda nikwithwa na government ithwe na muvango museo policy muvango mwau wa kiwu na masilanga aya ethiwa ni kila ward silanga ili kila mwaka kana silanga itatu nene ikavukua na kiwu kiyumwa kiyumaala vaaya yiimana kiyietwe utumoni nikenda andu maaeke kwananga ivinda yingi maithi usini Madam Speaker niw'a kuu tii iveti nisyosyutaa kiwu syisyoka kwitu nituutaa na makasya Madam Speaker na aume aingi withiamaihi umantha mbesa nundu mundu ovie ikasya athi na nzau naisyoka saa muonza ooka ekita ukoma kamunyilini mundu usu ekasa kwitha na mbesa indii.

Madam Speaker kwoou uyithia ve thina na indi nienda ukulya county government yitu ivange muvango museo naku ututongeesye Madam Speaker withie nitwisi policy nzeo ya county silanga ili kana itatu kana itano kuanana undu mbesa siana ivukue silanga hii tuuneena nisyusie lakini mbingi syi vuti umwe wa kiwu ingi syi vuti ili ninisyi kwako silanga wakwakwa silanga wa Kwalalu wi vuti umwe ukathela kiwu na umbua yu usu ni silanga wa muthemba mwau nundu ithiwa wiimatethya ivinda ya thaano kwou Madam Speaker nienda nasye sianga hii iwtetewe vaa sysa Kibauni vaa tii sivukue nundu nyie tanimutui wa Kibauni andu ma vaa nimathina nundu vaa muingo kyanda kana syanda ili ai ni hardship area wasyoka wavita ngali hii vaa omwingo Katangi ni hardship area yo vaa vaseuvw'a ni kyau Madam Speaker kwoou vasiwe andu ma kuu vasiwe undu ikwikwa tugazetiwe ta hardship area kuma wauma lamini ukite uoo ni nthi ya sua nthei kwou syigazetiwa kuya nikana athukumi maitu maeke ui matransfer alimu niutukia, matakitali nimeutukia maendete kula misaala ukuivanwa nesa kwoou Madam Speaker eka nasye ni muvea nundu wa mwantha huyu na ndiasya silanga syitu siiwe ngiti sieke uthambia ku silanga situ siiwe andu maeke ulikaku nundu ve muisyo na indi tiyithwa tuinywa kiwu kiseo na indi nasye tuvande miti tutitukithye muvango wa undu silanga siuvandwa miti withie iyuvukwikani muthanga kila ivinda na kuyovwa gabions in addition withie muthanga utanavika vala vi kiwu nikana silanga syitu syithwe itonya kuamatainiwa iyikala ivinda yiasa nikenda withie twina muvango museo ula tiendete withie nitwisi andu maitu mayithwa maithinwa ni kiwu ni asanti Madam Speaker.

Hon. Speaker: Thank you, Hon. Mutinda. Hon. Cosmus Kieti; we are coming down the line as it were.

Hon. Kieti: Thank you, Hon. Speaker. Madam Speaker, nataka kusema ya kwamba mwaka jana nililetia mswada kama huu katika mbunge nikiomba county yetu ya Machakos tuweze kutengenezewa mabwawa ya maji na vidimbwi na pia nilikua nimeomba maji yawezo kusambazwa karibu na vile vile nilikua nimeomba miti iweze kupandwa karibu na dams zile ambazo tukonazo na natakakupongeza mwenzangu mheshimiwa Annastacia kwa kuleta huu mswada leo ndio tuweze kuchangia.

Madam Speaker, tunapo ongea kuhusu huu mswada nataka kusema ya kwamba ni mzuri sana wakati kama huu tumpoteza mama upande wa Kalama ambaao pia iko katika County yetu ya Machakos ambaye alikua anapitia karibu na dam kumbe kwa hiyo dam ukuta ulikua umeanza kubomoka mama akaenda chini na maji na akafa bado funeral.

Haijafanywa ni wiki hii tu ndio haya yamefanyika tukona visa vingi ama..kama vile mheshimiwa Mutinda amesema ng'ombe ambaao wanaenda kuchota maji wameweza kuingia tena ndani ya vidimbwi vya maji napia wakafa kwa hivyo wakati tunasema tunaomba County

yetu iweze kueka fence mahali kuna dams tunasema kwa vile ni maafa kwa watu wetu na kwa wanyama wetu ambao wanaeenda kunywa maji katika hizo dams.

Kwoou twiasya itha nivatonyeka County yitu ya Masaku yumwe muthanga ula ulikila ndiane yu tuuneena ve dam yitawa muoni dam inenganae kiwu Kathiani ndia isu kyama Mheshimiwa Mutinda waweta mheshimiwa Speaker ndia isu kiwu kila kivovo ti kya vuti ili na ni ndia nene itwie inengaa Kathiani kiwu lakini tindindiku. Kwou twikulya dams syitu ivukue na kila kingi ivandwe miti na muno muno iyiiwa. Mheshimiwa Speaker ve kindu kya vata andu maitu nimakwie muno nundu wa mauwau na nauwau maingi kwianana na kisomo mauwau maingi maaumaa kiwuni. Na kiwu kii kitekiite kiilea kumina andu maitu.

Twina cases nyingi twikwasya sya cancer, cancer ya ivu, bilhaarzia na amoiba syindu isu syonthe syumaa vaya kiwuni natwikulya kiwu kii kyamina kumwa vaya ndiani kitananewa andu maitu nikenda makatumie misyini kiwu kii ethwa nivatonyeka county yitu iseuvye treatment plans kiwu kikambaa kuiitwa kiinewa andu nikenda makanywe na kila kingi Speaker tuasya kwi kundu twiona kiwu kingi oandu matonya kuima sukuma ovu vakuvi nituuukulya vala vena dam nene itonya unengane kiwu o kyauvanda mboka dam isu andu nimanewe okamuveleki kana mavinguiwe o kamatalu kanini withie nimatonya uvanda mboka nikenda withie nimasupplement nutrients nthini wa family syoo nikenda witie andu mayiutengemea mbokaila ikuma Ilovi na kyamuthya Madam Speaker nienda kyasya mwene nthi aimizwe nuthukuivinda ta yii twithiwe na mbua yingivite ou na mbua iyuka uthi mwene nthi aisyoka usini. na witha wi useo ula utonya akethwa na itangi nundu ninwe serikali government yambiia vala tui na twatwika ivinda yoonthe twiatia county government tusyaisye nationa government nikenda itunenge kiwu nituuvaluka na mundu ula able nembla nikuua mutungi wa litre yiana, ula wi able kuua mutungi wa litre gili itano ula wi able kuua iviva ya ngili ikumi nituue matangi nikenda mbua iyuka uthi ukethiaa mbua yathi kuikui silanga straight nitweethiwa ona ivinda ya kiwu tutonya utumia o misyini na kiwu kya utumia kkungithya indo nakuima mboka. Ni asanti Madam Speaker nundu wa mwantha usu.

Hon. Speaker: Thank you, Hon. Cosmas Kieti. Hon. Kisini.

Hon. Kisini: Asante Madam Speaker. *Kwa masiyitwa ingi nitawa Mheshimiwa Kisini kuma Athi River na ninye niungamie uvoo wa kiwu kiu kiuwetwa vaa na ninye niungamie uvoo wa mawithiululuko na ningutunga muvea muno wa mwanya kwa Mheshimiwa Mutuku Annastacia nundu wakuete motion isu, Madam Speaker. Niikwatya ndiee o ngewa nini; ya mbee ni kana nonanye Mheshimiwa wa kuu undu wendete andu ma kuu makwate kiwu. Niwaetie motion katika mbunge ila yendaa tuke usisya kiwu niasya kitawa Kiaka water project; kiwu kila kitavikia andu nesa na kiwu kila kyaia kuu nziani na nitwookie nanitwatemebeie na nitwavitukthisye ripoti isu ya kiwu kiu asukumite muno.*

Kwoou niasya nimuvea wa mwanya Speaker nikwitha mumbunge usu wa kuu niwambie ona thina usu nanitaandikie ripoti na niyavutukithiwe ni mbunge ya kana kiwu kiu kya Kiaka nanikinewe kila mundu nakiseuvye nakikunwe kiende kiimani ulu.

Kya keli kuka kuu unitumitwe nuwe Speaker na Committee yakwa nitwookie nundu wa silanga usu wawetwa munene natwoona ve wia munene muno uendee. Vai o ngusanisyo nini nundu wa kithangathi na contractor ateenda kumina wia na nitwookie nanitwaandikie repoti natwaasya contractor amine wia nikana andu nanewe kiwu.

Niwasukumite muno nundu wa silanga usu uthere ivinda yiu ndwaiunathela nanitwoonie silanga usu ukathela nikunenga andu ma Ikalaasa kiwu ona ukanenga andu ma kuu Kibauni

onthe kiwu. Kwoou Madam Speaker, nitukite kuu muno nundu wa ngewa ya kiwu Hon. Mutuku asukumite nundu wa thina ula wi kuu nanitwoonie kwi thina nundu tuendete usisya nitwoonaa mang'oi makuite maendete kuuta kiwu na nimaendaa distance nene kwa kitumi kiu motion isu ya Annastaciah ya kana andu ma Kibauni manewe kiwu---

Hon. Speaker: Who is Annastaciah?

Hon. Kisini: Hon. Annastaciah Mutuku.

Hon. Speaker: That is better.

Hon. Kisini: *Manewe kiwu onakwa ningumiunga mukono ta ni chairman wa kiwu namawithiululuko. Niki? Nikwitha nitwoonie ve vata munene na nitwoonie andu ma kuu nimaendea kuta kiwu vaasya. Nikulya oundu uandikite motionini yake kiwu, kiwu kinyaaike andu nundu kivo na ni kingi. Silikal wa County ya Masaku uthiuukye kiwu kiu wise kwithia andu nimakwata kiwu nundu isilanga yi vau ndi na utethyo Mheshimiwa Speaker itekunyaikiwa andu withie thina usu wa kui uta kiwu vaasa niwathela nundu u silanga ni munene na kiwu kiu kiithela nawakitwe usini na nitwoonie isilangani nivakitwe treatment plants ou kuukulaw'a ni ayumbe angi nitwoonie vaile ithwa vena trreatment plant ikiwu kikambaa kuuiitwa kiikuniwa andu.*

Nitwoonie kiinamba kwiwiwa na nenge niwakulya kuiia, kuvukua na maundu maingi kwou o silanga isu kati ka silanga ila ingi mbingi waweta vaa, nitukulya nikana withie niyaiiwa wise ithia nao ti danger kana ti kindu kithuku kitonya kuumisya andu.

Kila kingi nitonya kuweta ni uvoo wa kithangathi; andu ma Kibauni nidonya umakaathia muno nundu ninoonie kithangathi kuu na nundu kio kati ka environment kana docket yakwa ni noonoe kithangathi kuu kiikuawa ou na nimasuvie na mbusi sya kuu syi kithangathi nduuta ukauta niwonanawa naku. Kwoou ninamakathiia mumo nundu nitwoonie nimasuviiite kithangathi muno nakyo kithangathi nikyo kiiia kiwu nikyo bedrock ya kwia kiwu na nokyo kitumaa wisa ithia vandu nivaendeea ona miti.

Kwou nitukathia kiu muo nundu wa wise kwithia onasyo imbusi nisyasuviiw anundu nosyo ietae I kiwu withie iutwa kiwu, Madam Speaker, kana kithangathi kiuvukua vate muvango. Kila kingi ndonya kwasya Madam Speaker, nuvoo wa miti nitwaumisye report ya kana kila vandu na kila Ward inengane miti nikana ivandwe na nadineenea kuu Kibauni ve forest nene muno yiku Ikalaasa ila niya temiwe miti ona vai kindu na ona umunthi Mheshimiwa wa kuu Hon. Mutuku noungulasya kana muvango wa miti wavikiie va.

Nitwavutukithisyne kana kila Ward, kila Sub-County inewe miti ni kana andu mavande natasyoka twaasya isio ila sya selikaki sienda andu malikite kana itemetwe miti nifensiwe kana nisiiwe nikana wise ithia miti niyasuviiwa. Nikulasya oingi twiokuu Kibauni muno muno forest isu yikuuya Ikalaasa nundu ninonie ni forest nene County Government itenge mbesa na iyuka wise kwithia niyavanda forest isu niyatungiwa undu yailye tena na o kila vandu ingi vaivandwa miti okwianana na motion ila tavutukithisyne mbunge.

Uvoo wa silanga onawo nitwavutukithisyne kana onawo twathiuuka kuu kwonthe tathi kuya Matungulu kwa Mheshimiwa Moffat silanga yitawa kwale kyamutwoo nakuu kathuiana kwonthe nitaendie natwavutukithya twasya otou Mheshimiwa Mutinda ukwasyaa silanga futi umwe ivukue ingi nundu nisyo silangi isu nisyoithasya andu nitavitukithisyne mwiao usu natasya kana silanga nivukue.

Mheshimiwa nineenea kuya kwakwa Athi River kwisila motionini isu ya Mheshimiwa Hon. Annastaciah kana kuya kwakwa onakwo nikuenda silanga ona kwi town nundu nivakene na Amasai ve andu niungamiite Amasai na Amasai ni ma indo na maisilanga matonya kwika nakuma onatwawitukithya silanga isu ndyaisa uvukua yila tunavutukithasya supplementary budget Mheshimiwa Speaker tinaisyte kana mbesa mbingi mbingi nundu kuu ukamba kwi thina wa kiwu siende masilangani.

Nikulasya this time round twithe twi serious na tiikulya ofisi wa county masilanga mavukue kila vandu nikana wise ithia kiwu andu maiulatya vaasa nakiwu andu nimeukwata kwa vakuvu na ino syoo namimea yoo nikukwata kiwu kwoou niasyaa Madam Speaker, ningunga motion isu ya Mheshimiwa Annastacia mukono na kwasya kana masilanga aa angi nundu nitutengie mbesa ala me silanga wa Endau, Kasengela, Kwa Mating'a dam Kibauni yonthe inywe kiwu. Asanti, Madam Speaker.

(Applause)

Hon. Speaker: Thank you, Hon. Kisini. Hon. Kalumu Francis.

Hon. Kalumu: Thank you, Madam Speaker. Again jina langu ni Francis Kioko Kalumu nawakilisha watu wa Kithimani katika mbunge la Machakos County. Nataka niseme kwamba maji ni uhai water is life and the only thing Madam Speaker, unaeza patia watu wa ukambani kama serikali ya Machakos County inaweza patia watu wa ukambani ni maji kwa sababu saa ile watu wamepewa maji kwanza.

Research inasema kwamba mtu anaweza kaa siku kutoka nne hadi saba akiwa hana chakula bila maji lakini akipewa maji anaweza ishi hadi siku kumi na moja; kwa hivo hiyo nikunyesha water ni...water is life. Again maji inaeza tumika kuinua economic status of the people of Kibauni sababu saa ile kama ile dam ya Mumbuni ikichimbwa ikue na maji watu wanaweza lima kidogokidogo wauze sukuma wiki, wafanye biashara ya kuuza matunda kidogo lakini hilo haliwezi kufanyika bila maji.

Tofauti ya sisi Ukambani na watu wa kule Kikuyuland ni maji. Kwa hivo yunaomba serikali ya Machakos kupitia Gavana wetu Dr. Alfred Mutua awezeshe apatie mwamanchi nguvu ili aongezee employment. Maji inaweza create employment in Ukambani sababu area ya mchanga yetu na mashamba yetu ni makubwa na yanaea nyunyuza maji yanaea wekwa maji na watu wapate fedha mingi sana.

Lingine ni kusema upandaji wa miti around the dams can help so much sababu inaeza shika ile mchanga isitiririke ama kwenda kuziba ile dam na hiyo inaweza zuia maji ambayo purpose ya kuchimba ile dam ilikua ni kupata maji ili dam isizibwe na watu waendelee kupata maji kwa kiwango cha siku mingi sana.

Kwa hivyo tunauliza na tunaunga mkono mswada wa Hon. Annastaciah ambaye ameona ni vyema watu wao waweze kupata wake watu wake waweze kupata maji kutoka siku ya leo tutakua tumepitisha na sio wodi ya Kibauni peke yake. Kwetu mahali nimetoka dam nyingi ama vidimbwi mingi za maji zimekua hazipo sababu mchanga imeingia na tunaomba serikali ya Machakos kupitia Wizara ya maji iweze kua na mpango kabambe; fedha fulani zipangwe ziitengwe kidogo ili iweze ku de-silt ama iweze kutoa ile mchanga kutoka kwa zile vidimbwi ndio wananchi waendelee nakupata maji.

Tunauliza pia kwa zile wodi zingine hazina dam kubwa kubwa kama hii inachimbwa huku kwa Mheshimiwa Annastaciah, kama kwangu hakuna dam kama hiyo tunauliza kila wodi

iweze kufaidika na dam moja at least ndio kila Ward waweze kupata wainuke kifedha wainuke kwa sababu maji in prolong life. Where you treat water well, it prolongs life because treated water is better than untreated water.

So tunauliza pia wakati ule dam zimechimbwa ziweze kua na treatment works ndio maji yawe masafi watu ikue free of diseases. Ikiwa free of diseases watu wetu, hata fedha zetu ambazo tunatenga kule Machakos za madawa yatakua machache. Hiyo ndio maombi yangu nana support kwamba vidimbwi viweze kuchumbwa kila Ward. Shukrani.

Hon. Speaker: Thank you, Hon. Kalumu. Hon. Members, I call upon the mover of the motion Hon. Annastaciah to reply.

Hon. (Ms.) Mutuku: Thank you, Hon. Speaker. *Mbee eka nitunge muvea kwa Hon. Members ala machangia motion isu yina vaita munene kwa andu ma Machakos County ona ti kwa andu ma Kibauni kyoka....*

(Applause)

Nimutungie muvea wa mwanya nundu kila umwe vaa niwisi thina wa maisha na andu ma Masaku. Hon. Speaker, nikutungie mvea wa mwanya muno vyu nundu Mumbuni dam ila yaetie issue nanaete statement mbunge niwaungamie nakwa nawetha wi in a position ku control the mood of the House na watuma Chairman wa environment and water naathi aaete ripoti nzeo nawatunga contractor site nokulingana na ripoti undu yooke Chairman aetete na contractor niwasyokie but unfortunately ookie yila ivinda ithuku mbua yiingie.

Kwoou silanga usu bado nutialitye nanikyo ngukulya kila His Excellency Governor ndimutungia muvea nundu wa silangi usu ti mboneki Machakos County; niikwatya ni ili na ni ila yi Ndalana Ward na Kibauni Ward. Nimutungie muvea wa mwantha muno nundu niwoonie silanga usu wailite Kibauni ward. Thank you, Hon. Speaker.

Mheshimiwa Spika, ngutavye kana Ng'omano ni location nene muno vyu na silanga uu wikwiw'a uyitwa Endau wakuuiwe ni mbua ya 2017 so kwina na two years andu ma ngaliko ii mate kiwu. Yu tuuneena Ng'omano ndi mang'oii nimanakui oonthe nundu nanoosaa kiwu Thwake usini ing'oi inaendaa two days uni ungi ikalea kukila nundu vai kindu iya na I distance.

Na kiveti kikuite ing'oi Hon. Speaker, niarendete utava kiwu, kiendete ungithya na nikukuite mutungi na nikyo naete motion ino umunthi kuu nikana silanga usu wi vaaya kimani kya Kibauni yiulu na silanga usu wai munene wezitwe ni National Government kwisila ivinda yila Mheshimiwa Katuku wai elected MP wa Mwala Constituency. Kwoou area ino yina thina mwangi muno wa kiwu vyo nayu wisisya mbua withia kiwu kiendete na ng'ong'o kiendete Indian Ocean.

Nikulya selikali ya Masaku ika concetrat Kibauni nakutwakia masilanga vaa ve borehole yenziwe vaa Hon. Speaker yalea uma kiwu ingi yaakwa vaaya sukulu yalea uma kiwu. Kasilnga ke vaa o kanini ke vaa kuela soko kanai kangalu kwou area ino yonthe yina thina muno wa kiwu o thina wiokwo Kibauni.

Ikalaasa location nimaneekwatisye silanga usu wa Mumbuni walikile kiwu sua umwe indi kiwu kyu kinanywiwe season isu yoonthe; andu manauamaa kilometres makoka utava kiwu lakini uyithwa matava kiwu pure kiwu kitena thina na kiwu kitekmyakwovya laini andu aa onthe ma Ng'omano Location hii ni sub-location ili ve Kilala sub-location na ve Kiunduani sub-location na Kiunduani sub-location nikuuya wonie undu tulikile na kwa imagine distance isu Hon.

Speaker maithi utava kiwu usi usini Thwake na ethi ambo uvanga laini so nudu niwisi kyama Mheshimiwa Mwikali waweta mundu muka ate kiwu ndakomaa na ta nimundumuka mutongoi nikyo nambite unenga kiwu priority na priority ya Kibauni nikiwu wamuka, ni kiwu watinda nikiwu.

Kila kingi Hon. Speaker, ngulilikanye kana silanga uu nawo ukwitwa Kasengela no the same situation; ona ti wausuviwa ni wa kwinzwa na ngulya County Government ya Masaku vandu va uka omavukuange ou ma contract silanga usu noyakwa undu vaile ndukasyoke uka ukua andu ta ula ukuie andu vaa Thwake.

Our neighbouring vaa Makueni ve silanga withitwe kila season kwaua wiikua nikiwu. Recently nukuiwe ni mbua ino na we andu atatu manakuuiwe ni silanga usu na winzawa ni County kwoou nikulya kwa ndaia Governor witu wa Machakos tumwendete nawendete andu onthe ma Machakos County ila ukwinza masilanga akite u contract nikana twakiwe kindu standard ti sub standard.

Hon. Speaker, Kasengela no the same nayo niyakuwe isu ikuite two locations na vai kiwu onakinwe yi the other side of the Location we Ikalaasa yi vaasya but mo asu manathea usini wa Athi kila manafacia muno muno thaano usu nikunethaa na issues sya kwituua nundu wa kiwu kya Athi nikyo mananyusaa. Kkwoou Hon. Speaker Kibauni Ward yina mathina maingi muno vyu na nengi nitungia serekali ya Machakos County muvea nundu ivinda yoonthe nanengana vata wa andu makwa ma Kibauni Gavana Mutua niwithaa e keen na e serious kuka usisya thina woo ni mwau.

Recently tunai na His Excellency Deputy Governor atumitwe ni Govana oke usisya thina wa Ng'omano nundu wa mang'oi kwitha makuiie nziani nakuniewe visa kuu syatumwa na namuforwadia ni kana amanthe thina ula wi Kibauni na Hon. Speaker ni kindu kiseo Kibauni nikumu muno nikulya ingi kwa ndaia kwa serikali ya Masaku yiete programme sya tree planting ni kana mawithiululuko ma itu withe ivinda ya sua nikwetha kwi okavaa na kutekuvyu muno nundu kuu yu ukite kuu kwi mbua nikuseo.

Lakini ukoka unewa eka ikumi sya mana kwi mbua Kibauni kwi thano ndwosa; ndyitikila nundu usiasya kundu kuu ukona kwi maisha lakini nikwitu na nitikwendete kwou nikulya ivindani yii ya utongoi wakwa nundu ivinda vila neetasya kivila Hon. Speaker neea andu makwa Hon. Speaker ni ready ku transform Kibauni na actually Ngai andethya oundu tuendee notukitiila o vandu veo kavaa nundu ninikiite vitii nina Hon. Members nimatungie muvea nundu wa ussupport motion syonthe ila nietaa mbunge; naku wivo nundu wa isu nguvi na masaa Hon. Speaker eka ngutungie muvea wa mwantha na ndikwia congratulations wi mutongoi mundu muka the first Speaker in Machakos County.

(Applause)

Nutwithukisyaa ithyonthe na kila umwe ayuma kwake ayuka na mood syake na stress syake uitu control. Asanti nundu wa unenga opportunity ino; kuka vaa kwakwa ti aki yakwa nundu kila umwe nookwenda kwake kuendwe but we mwene wona ve vata kuete mbunge Mashinani Kibauni wamba umantha thina wa Kibauni. Hon. Speaker Thank you, very much. Ngai nakuathime muno nundu wa unenga priority.

(Applause)

Nakunenga andu makwa priority ya kuka kwamba kumethukiisya nakwosa thina woo.

Ndimina Hon.Speaker, Mumbuni dam, His Excellency Governor niwaisye kana silanga usu wenzwa matangi makaambwa vaaya kiimani; the other side of Ikalaasa Location nikana seemu usu wi nguumo wa kiima kiwu kya pumbiwa kikaendaa na gravity. Lakini mbika vau silanga usu nulikile kiwu so niukulya kwa ndaia okwisila utongoini waku na mbunge na ambunge ala me vaa onthe silanga usu uminwe na wii succeed na andu makwa mai kwata kiwu undu I plan yailye nikana naitu tuendee kwasya ni asanti kwa Ngai na utongoi waku ta wi Madam Speaker, ni museo nundu ta kethwa we ndunaa ikala nthi na Governor mukeeka handshake Masaku inaiinaakana mwaki.

Hon. Speaker, *na tuyithiwa vaa lakini nundu nunekie handshake na wooka watwikalya nthi ta twi syana syaku Hon. Speaker naithye ithyonthe tweka handshake nikyo twikwona matunda aya kwoou Ngai nakuathime nauyiendee kwitha wi mutongoi mui na mundu muka mui ula wakaa musyi wake na moko make.* Thank you, Hon.Speaker.

(Applause)

(Question put and agreed to)

Hon. Members, you have passed a resolution on this very important motion because we all say water is life and the Constitution of Kenya appreciates that fact and gives the citizens of Kenya, each one of them, the right to clean water in sufficient amounts. So by passing this resolution, you are, as a matter of fact, making sure that the constitution on the right of the citizens to clean and sufficient water is implemented and for purposes of implementation of the motion you have just passed, the resolution is committed to the committee on environment.

Hon. Kisini you are here; the committee on Environment, Energy, Lands and Natural Resources and you have already done quite a bit particularly for the people of Kibauni coming here and seeing as it is on the ground. So, it is in that same breath that we are committing this matter to your committee so that you can take it and make sure that implementation.....sing and dream about implementation of the motion that has just been passed. Thank you. Hon. Members, we go to the next order, Mr. Clerk.

Hon. Speaker: Hon. Members, under this Order we have one business by Hon. Majority Leader and the Majority Leader for the time been is been represented by the Hon. Dominic Ndambuki. Hon. Ndambuki please proceed

Hon. Ndambuki: Thank you, Hon. Speaker. I am holding fort for Hon. Majority Leader. Hon. Speaker that aware that Standing Order 24(1) provides that except for the session commencing immediately after a general election, the regular sessions of the Assembly shall commence on the second Tuesday of February and terminate on the first Thursday of December;
Aware that this third session of the second Assembly begun on 12th February, 2019;

Noting that crucial business has been transacted during this Session including approval in budget of the County for the Financial Year 2019-2020, facilitating public participation on various legislative proposals, vetting and approval of officers of the County Government;

Acknowledging that the House approved an Assembly Calendar pursuant to Standing Order 25(1) and aware that the calendar of the Assembly guides the House on when to have a break and when to resume sittings;

Aware that the approved Assembly calendar indicates that the Assembly will go on long recess from 5th December, 2019 to 10th February, 2020;

Aware that the recess will accord Members time to interact with their electorates and relax over the December festive season;

Further aware that Standing Order 25(3) provides that on a day when the Assembly is scheduled to adjourn to a day other than the next normal sitting day in accordance to the Assembly calendar, the Leader of the Majority Party or the Leader of the Minority Party or any other Member of the House Business Committee shall move a motion of adjournment which shall be debated for not more than three hours after which the Assembly shall adjourn without put;

Hon. Speaker, I beg to move the motion that this Hon. House adjourns its sittings as per the calendar of the Assembly from today 4th December, 2019 and resume on Tuesday 11th February, 2020.

Thank you, Hon. Speaker.

Hon. Speaker: Hon. Ndambuki, a Member to support your motion.

Hon. Ndambuki: Thank you, Hon. Speaker. I call upon Hon. Moses Mitaa to second.

Hon. Speaker: Hon. Moses Mitaa.

Hon. Mitaa: Thank you, Hon. Speaker. I support and I don't know whether you will allow me to make my submissions, Madam Speaker.

Hon. Speaker: Alright.

Hon. Mitaa: I second.

Hon. Speaker: Proceed.

Hon. Mitaa: Thank you, Madam Speaker. Congratulate my colleague Hon. Dominic Ndambuki for the motion he has brought. Madam Speaker, *ndineena kithyomo kila kikueeleleka ni kila mundu twi vaa kana aingi ala twivaa nikana ukulyo uu waetwe nikana twithe twina ivinda ya kuamukania na mwene nthi kila muthenthala nundu Madam Speaker, ivinda yila twithiitwe twi wiana aingi maitu ala twikalaa misyi twamukaa kyakya na twisaa usyoka misi wiyoo lakini mwanya uu twanewa, Madam Speaker, kana mwantha huu ukulw'a yu mwene nthi nukuvikiia kuma kwakya kuvika wiyoo kutindanya na MCA wake.*

Hon. Maitha: Thank you, Madam Speaker. Niitawa Mheshimiwa Moffat Maitha kuma Matungulu West. Madam Speaker, nienda kuunga mukono Mheshimiwa Ndambuki motion ila waete ya aheshimiwa maende mathyumue, malikane na andu moo ala mamasakuie vandu va myei isu ili Madam Speaker. Madam Speaker, twiawa ona andu mathukuma nimaeile uthy whole kwoou uu ni muthenya museo tuneenaya nikenda tunewe kamwanya nikenda naitu twende tuthyumue tukwatane na andu maitu tuneenanyie namo na tuivanga mivango ya matuu asu angi mokite.

Madam Speaker, oondu wewa Mheshimiwa Mitaa aneena mbua inae mbingi na malelu nimanaangikite pyu kundu kwingi ona kumwe ukethia kwilikika Madam Speaker, kila ndonya ukulya the Government niyu twi luusa etha ninengetwe mbesa kuma kuya National Government itate undu vatonyeka ililikane mathina ala me kuya nthi anduni maitu nikenda malelu tuseuvye na maundu ala angi twailekwitha tuyika na mbesa ila tunavutukithisye budget withie nisyaetwe nikenda tutethye yii twi luusa Madam Speaker.

Kieti you even did not have your hand up so please just warm your seat so let us have Hon. Comus Masesi because even as I was talking, I was looking at him. Hon. Cosmus Kieti if you have something you will say it later

Hon. Masesi: Thank you, Madam Speaker. Madam Speaker, *ingi nienda niwete isyitwa nundu wa kwitha isyitwa kwitha ninisi ndinena ngi nasye ni Cosmus Ngula Masesi Mheshimiwa mutang'wa Madam Speaker na nzukulu kwa atang'wa, Madam Speaker, kuma kuya Matungulu ya umiloni wa sua. Madam Speaker, nienda ukwata okwoko ingi ukulyo uu wa kana twamboi break Madam Speaker, nginya mwai wa keli matuku ikumi na yimwe na indi Madam Speaker, ndiasya aheshimiwa mose vinya nundu government yithwaa yi different na kwina maundu maingi Madam Speaker.*

Madam Speaker, *mwenenth ena mavata maingi na indi twikulya o Ngai atunenge twithe twi nthi na aitunenga vinya tutetheanisyne na andu aa nundu Madam Speaker, tayu tuunena kwina mathina maingi muno ma masivitali ma bills sya sivitali na Madam Speaker, andu maitu angi amwe nimaleile kwosa card sya NHIF oila yiivawa silingi maana atano Madam Speaker, kwa mwai umwe. Kwou nutukulye mwene nthi Madam Speaker, onakau Masaku twina M-Tiba ila yiitaa andu mana mose o card ya NHIF nundu wa kwitha ila wathi kuya sivitali ta Kenyatta, Madam Speaker, nduiitwa utena card isu. Matuku aa Madam Speaker, NHIF nikuungamia bill syonthe onethwa no million itatu ukethia mundu niwaiitwa na enuka e muima.*

Madam Speaker, *ingi nitungia handshake ila watongeesye mivea ya Masaku nundu umunthi Madam Speaker, twinakooa na twi mbunge mashinani na indi ndiia mwenenth Masaku nitwaekanie na kau yu tuneenete na wasya umwe kenda tuvikikiye umuthukuma na nzia ila yailite.*

(Applause)

Madam Speaker, *tuenda ngai atunenge uthukuma nesa nundu wasisya miaka yitu no nini na wia uu twina vata nawo muno withie nitwathukuna andu aa na nzia ila yailite Madam Speaker, Ngai atuvikya kwo meona ve kitumi kya tuendee na umathukuma nthini wa 2022 na ndi Madam Speaker, ndiasya ingi no muvea kwa aheshimiwa ala tukwatie mwanya twoka kuu Kibauni twiawa ni kuaasa na notwisi ona tukitie utea vala twikuendaa niwaa nivasanga.*

Madam Speaker, *andu ma kuu ninoona meatanu na ndimea maendee ona ngoo isu yaauthokasya andu ala mooka na silikali wa Masaku nuendea naumathukuma na nzia ila yailite.* Thank you, Madam Speaker.

Hon. Speaker: Thank you, Hon. Cosmus Masesi. Hon. Kisini

Hon. Kisini: Asanda ndaia syonthe kwaku Madam Speaker, na niosa mwanya uu nitungie mueti wa motion isu Hon. Ndambuki nundu wa kukulya tukuiisye mbunge nakwa ningunga mukono ndisisya kana nineethia ila nasisya no tunavitukithisyenakwa maundu maingi Madam Speaker, twavitu kithya miao, twaenda kuseuvya miao tulikanite na public, twasisya andu ala manaandikawa mailite ukwata maofisi, na maundu maingi ala tuneekie kwoou ivinda yiu tunaev tuinekala mana twii wiani Madam Speaker. Nikulya o ingi naitu tuende kikuiisyo kiu tuende nikana tukalikane na mwene nthi nbee naitu notienda uthi uiima notwaiia ni mwanya wa uthi uima nitukite maembe tukwate maembe nengi nikuseo yu naitu nituulika muundani tuime Mada, Speaker tuyiendete o kwiloela.

Kila kingi niasya nota ikulyo yiu yeewa kana oyii twi musyi vayi ivinda yitena wia ngai nutuathimite na nutunengete mbua nakwitha atunengete mbua kwina kiinyu na nitutonya ithwa tuimite natuimite uleu tuileu uuketha dawa sya kukuna nundu wa kiinyu kiu kila kiuya mbemba wisi kwithia yila twi musyi nitwasupervise na nitwalikana na enenthi withie ngetha ila tweltee ndinaa mana na nima ni mithemba mbingi ve nima ya mba liu na ve nima ya mba indo.

Onasyo indo ila kwekala ou nisyithwaa na thina niwo ikwatawa ni nthiana niwo ikwatawa ni ikeme notuukulya nayo dawa ithengeewe sya indo muno muno ila kwooka mbua niwo indo syikwatikaa ni mauwau asu Madam Speaker, nikana wise kwithia silikali wa county niwamanya ii kwi mbua nesa nikuenda dawa ya kiinyu nikuenda dawa sya mbaa indo nikana wise kwithia isyindu nisyasuriika na imbuwa twinaketha mana nitwakwata okindu yii twi musyi niikwatya nituitha na ivinda iseo undu aheshimiwa maasya ya kulikana na andu yakuisania sikuku na indi ngai aitutethya tuuka ukomana ingi matuku asu meethwa twi aima na tweteele kusisa undu syana iusyoka sukulu ningwikwatya kana nituithwa tuneethwa na bursaries wise ithia syana ila yiusyoka masukulu nitwainenga asante.

Hon. Speaker: Thank you, Hon. Kisini. Hon. Mutinda.

Hon. Mutinda: Thank you, Madam Speaker. Isyitwa yakwa ni Thomas Musyoka Mutinda Member of County Assembly Wamunyu Ward. Eka nasye nitungie muvea Hon. Dominic nundu wa motion ino waete na ndiasya ni ivinda iseu yitu ta aheshimiwa twinunke tukethe na andu ala angi musyi na indi naitu tuithumua Madam Speaker, ninisi niwisi nikwiawa all work and no play makes Jack a dull boy.

Kwoou tuakendee ou niithia wiona andu makitite kuinanywa mutwe lakini yu twathi twethwa na andu ala angi misyi Madam Speaker, twiitha tuendee nesa na indi ndyasya nundu nuwe tuutia uvisini tondu we withaa na mavinya eli wi vinya wa siasa, wi vinya wa uvisi utusiaisye maundu withie nimaendete nesa tumite yuani kuma mwai wa katano vala mbua yaendele na yai nini kwou enenthi maitu vala tuendete onaa tinamo vaa maumit kuua liu kwou undu syana syivungua sukulu mwai wa mbee mayisi na nundu ninywe nwi ovisini Madam Speaker, wina Governor mutusyaisye wise kwithia January tuizungua nitweetha syana syitu itonya ukwata bursary nikenda syana ivungue sukulu kwa ulahisi.

Indi kila kingi nuona undu mbua kuiie kuie muno syoo mbingi sya public ta masukulu siendee na uvota kwoou nthini wa ila emergency kitty, Madam Speaker, isiw'e nikana report ila twikwitha tukiete nundu kula twikwitha tutembeete twitha tunetwe navata naotumwithiite vaaya mutatite undu mutonya utumya nundu ekethwa yi aivu muno ithwa tukooka twiwe primary school ina ndivinguikya sukuli nundu vai kyoo. Kwoou wambe ikalwa nginya kyoo kise kwoneka

kwoou mbesa isu ya emergency isiw'e nikenda wise kwithia nitonya utethya andu nikenda withie maundu nimaendee kikawaida.

Kiingi ni nzia musisye mbua iyuka unyaa vethwe ve mbesa nitunavitukithisyen budgetini million umwe wa kila ward wa nzia withie million usu witayari kana onenthwa twiambiia na phases omaana atatu atatu kiala ward ila ingi ou tuendee nikana nzia syitu tuitunge vala syii nundu syi inaanangika undu mbua yiendete na wasisya ndivyaa tekuthela mituki. kila kingi wasisya miundani, Madam Speaker.

Kwina ngetha tuenda serikali witu wa county ukwatane na KEBS na National Government tusiawiwe dawa ila nzeo nundu yu naitu and ma kuu tukuniawa vau andu mayiete dawa itekwo maituteea tuwikia makuniani natuyisyen ithia twina liu. Kwoou tuetewe ndawa ila nzeo, ndawa itngaswe ila andu mailite kuua nundu twina muvea witu wa kilimo nanitwisi kilimo ni devolved twikese kwitha twina mbua twina liu na twaketha vathei.

Kwoou Madam Speaker, tusyaiwe maundu asu na ala angi nikenda withie; tuithi kwosa mavata ala angi asu nimasyaitwe nundu nao ku twathi twai kuete mavata na indi ndyasya ni muvea aheshimiwa enzangu mwathi endai nesa, enda nukeyumiisye kwikala kuku mukune mawia maseo na indi tuyukala na tuyuka mwi aimi nikenda withie nitwooka kuendesya mbunge. Kwoou nyie ndiuvika vau nandyasya ni asanti, Madam Speaker.

(Loud consultations)

Hon. Speaker: Order, Members! Hon. Kituku.

Hon. Kituku: Thank you, Madam Speaker. *Nayu nina woni tofauti kidogo undu Mheshimiwa Spika vala calendar ka mbunge keasya twaile kuthiumuila vau twi tunaola matuku ma ku table Finance Bill nayyu niona tuyenda inuka kwoou twiona wia tutialitye alafu twina reports mbingi tutaminanite nasyo ndyisi tuikia special sittings kana veithwa vailye ata nundu kuna yuyu mbaka mwai wa keli tyo vaasa.*

(Loud consultations)

Kwoou Mheshimiwa Spika nyie avakwa ninguvunga kiu. Thank you.

(Applause)

Hon. Speaker: Hon. Annastacia. Thank you, Hon. Kituku.

Hon. (Ms.) Mutuku: Thank you, Hon. Speaker. *Niungama ni support motion ya Mheshimiwa Ndambuki nundu ve vata onaitu tuthumue twiona families na no tuimaa natuyithwa ona ivinda iseo ya kwitha twi anduni aa maitu na Hon. Speaker ninew'a Mheshimiwa waasya wa Wamunyu kana nitumie nzaani Kibauni bado kwi nzaa.*

Hon. Speaker, Kibauni nindi maie nyunyi na nowoka usyaitwe woona ona mbemba ndinauma mwinthuka naa mukamba asyaa nzaa ithukilaa vau yu. Yu kwoou niendaa kuutavya kana Hon. Speaker andu makwa me o nzaani nanengi nyie niitha ground ndembeete kuu ivetini, atumiani ala akuu andu ala matemamutha maseo na matuku 13 tukethwa na program ya disabilities o kuu Kibauni kwisila kwa Mheshimiwa Katumo.

Kwoou utembeeta Hon. Speaker, nundu now you are a public figure na wi National Government kati ka County Assemblies Forum (CAF) ukati uilye uu ukakomana na donor kana o well wishers kwa ndaia with all due respect Hon. Speaker ndilikane na andu makwa na Kibauni bado mena nzaa mbingi muno. Na nengi Hon. Speaker ndiutungia muvea nukite ou utumite vaaya nona o ka pick-up kavita okakuite o mutu. Asante sana mum. Thank you, Hon. Speaker.

Niniisi umunthi muthenya uithela na nikyo Hon. Speaker naungama ni mutongoi mundu muka na naasya mundu muka e ngoo nene naku ninisi you have that big heart and passion to support the needy. Kwisila uvisini waku kila wooka ukuite ta kiveti wooka ukuite nthungi na andu makwa na Kibauni ngwona umunthi ona utandavitye kila mama wi vaa nukwinuka ona mutu onethwa no muvuko umwe.

(Applause)

Thank you, Hon. Speaker. *Ngai nakuathime muno naikwongeleela we na family yaku nouyiendeaa ithiwa na ngoo isu na kila mheshimiwa waneena vaa handshake niyo inutuma tuvika vai tuvikite na muuo wa nthi kwoou tuendee nakuu support natuyuvoyea naku uituvoyea andu aa onatwamathukuma metulilikana o 2022 tukwe kwoseleele o vamwe naku. Thank you, Hon. Speaker. I stand to support the motion.*

Hon. Speaker: Hon. Phoebe Koki.

Hon. (Ms.) P. Koki: Thank you, Madam Speaker. I am Phoebe Koki, special elect Member by Maendeleo Chapchap. Madam Speaker, *sitaki kuunga mkono mswada ulio letwa na Mheshimiwa Dominic. Ninye nanena vandu va chairman wa finance Hon. Stephen Mwanthi Nzue from Ikalakala ward na Members kulingana nondu twoona ila first reading ya Machakos County Finance Bill yasomwa, nimwona tuikuvivya matuku kwoou Madam Speaker, nyie kyakwa nikuvoya, ethiwa nivatonyeka.*

Mukamba asyaa ng'ombe sya wia syeew'a mayoki maikwatangwa, syumaa kituuni ikeyete na nundu ndienda ita aheshimiwa aa ng'ombe lakini nienda asya ni andu ma wia keka nivatonyeka syumwa kenda ni mbingi muno tuliyet musyi, nanyie ningwiw'a ta ngui uwaa ingi nundu nina ndetema nekala muysi muno ndeutethya wia. Madam Speaker, niinikulya ndaiani syonthe nundu wa commiitee ya Finance twongelwe syumwa withie nitwa break kyumwa kya matuku miongo ili kana matuku miongo ili nemwe.

That way, *mwei wa mbee tukeethwa na ivinda iseo ya kuthukuma kwikala na andu maitu nakuthumua na nundu wa kindu kii twisi vata wakyo nundu aeshimiwa ambunge nimaneenanisya kyo ethwa nivatonyeka twongele syumwa ili nikana tunenge Bill ino ila yitawa public participation maybe kyumwa kiu kiukite nakiu kingi tuiminana nayo Madam Speaker, nundu ninisi wina vinya usu wa kwika ou nyie ningutungia muvea muno wamina kwika ou asanti Ngai nakuathime na tuyithwa kisimis kiseo.* Thank you, Madam.

Hon. Speaker: Hon. Mwikali, everything has been said; I can almost read your mind especially now you are seated next to Hon. Kituku.

(Laughter)

Hon. Members I think you appreciate that no vote is to be taken on this motion because the decision is the Speaker's and the decision of the Speaker is communicated as follows;

That the Assembly sittings are going to be adjourned to reopen on the 11th February, 2020 at 2.30 p.m. after the 10.00 a.m. Assembly Annual prayers. Hon. Members, I will call for special sittings because I appreciate that there are businesses that must be transacted even as you are on that long holiday, you will need to address the Finance Bill and we also need to receive and decide on the report of the Appointments Committee on the approval hearings of the nominees for the County Public Service Board. Remember you have been without the County Public Service Board after the term of the Board that was there expired and you must have a board in office and then you may also have any other suitable business to transact.

Secondly, Hon. Members after we adjourn this sitting to the time I have indicated, we will have a committee of the Whole; just here for purposes pf interacting with the members of the public because that is the only way you are able now to talk with them on one on one and so once we leave this venue, the Speaker will take about minutes to go and change into a proper public attire so that we can have a chat with members of the public.

So, Members let me take this opportunity to thank you really very much because we have come a long way. We transacted a lot of business in the session that has just ended and then we thank God also because it is Him who gave us the ability and the energy and the sound minds to transact that business and then I want to thank the members of the public who are in the gallery. We have a very big gallery today and the visitors that I acknowledged in the beginning because they have kept us in this forum going and they have participated although been in the gallery in the proceedings of the Assembly as it is required under Article 196 of the Constitution.

Hon. Members, I also thank God really that today we had a very good weather; it is better to sweat like I am doing now than to be rained on when we are doing this business. So, God has been kind to us during the day; the rains can come later in the night because we still need them its only that we need to take care of ourselves on the excess waters and floods that are coming with the rains. Let us not blame the rains; let us us check on our conduct as human beings because we need the rains that is why we have all this green and I looked as I was coming here as Hon. Annastacia, yes we have food in the farms and that is the hope that we have.

What we can do now is little; the food that we are getting now is just to keep us waiting for the maize and for the beans to ripen and we have hope because our farms are green and we thank God for that.

Hon. Members, I wish you a merry Christmas and a happy 2020 but because we have members of the public in the public gallery and our visitors, we should remember we also have 12th day of December this year and that is a national event when we celebrate our Jamhuri Day.

We need to take part and participate in national events because if you don't appreciate your nation, if you don't practice patriotism, then you are lost. So, when we have days like Jamhuri day, I am urging all of you present here at least to go there and appreciate why it is that you are celebrating Jamhuri day. We need to carry on these traditions like many of the nations in the world do because if you don't have a nation that you can call *mama na baba*, then where would you go?

You see the many people host as refugees in Kenya because they didn't give much thought about their nation *na nyumbani ninyubani lazima tutunze Kenya ambayo ni nchi yetu na ikiwa ni siku ambazo ni za Jamhuri day, siku zingine ama National event tuko nazo tujitokeze kwa wingi tusikilize vile viongozi wetu wanatuambia na tuendelee kuilinda na kuijenga nchi yetu*

ya Kenya. Hon. Members, at this point I am going to take off but before I do that we were coming here to teach the members of the public about the business of the Assembly.

The members of the public who are in the gallery, you notice that there is a gold gold; what do you call this no not a mace to them its not a mace what is this? *Kijiti kuna kijiti kijiti ya dhahabu inaitwa mace kwa language ama kwa lugha ya Assembly na ndio ata juu yake ikona national emblem ambayo ni ile ya serikali ya Kenya na pia ikona emblem ya County Assembly ya Machakos.*

Hiki kijiti kina maana kubwa sana katika bunge; bbunge hili na katika bunge zingine zote ata zile National Assembly. Hiki kijiti kikiwa hakuna, hakuna bunge kazi inaeza endelea; mnaelewa hivyo? Kwa sababu ndicho kinaonyesha authority ya bunge ambaa mbunge imepewa na katiba ya kutengeneza sheria nakuwakilisha wananchi na ya kuangalia Executive ifanye kazi vizuri. Wakati waheshimwa wanazozana, wale wakona nguvu wanakimbilia hii, wanaiondoa na wanaficha. Wakificha hiyo, sasa bunge kazi imeisha inasimama hapo.

Kwa hivo wakati mnaona atumeiweka hapo mbele, ni kitu ambacho tunakipatia heshima kubwa ni kitu kama hii kama emblem ambayo viongozi wa national government wanavaa kwa kofia unaona; ukiona hiyo ndio unaona ata wanapeana heshima waheshimiwa wakipita mbele yake kwa sababu unapatia heshima Assembly yako na heshima nchi yako ya Kenya.

Kitu cha pili ningetaka kuelezea katika bunge kuko na pande mbili ambazo waheshimiwa wanakaa. Upande upande wa kulia kwa mkono wa Spika, unakua ni upande wa walio wengi kwa bunge ama Majority Party ambaa wanakaa hapo. Upande wa kushoto ni wale walio wachache lakini ata ukiangalia ni kama inaonyesha; sijui saa zingine wanachanganya au wanaingiana lakini kisheria huko kwa bunge na hata hapa, wanafaa kuketi upande wa kulia na upande wa kushoto. Upande wa kulia ambaa wanakuanga wengi ni wale ambaa wako kwa serikali ama ni wale ambaa hawako kwa serikali.

Wakati huu bunge la Machakos, wale walio wengi hawako kwa serikali na ni kumaanisha kwamba serikali ya Govana Mutua ndio ikona wale walio wachache na hiyo nikulingana na vile elections zilifanywa. Kwa hivyo wakati hawa walio wengi wanaketi pandee hiyo kazi yao inafaa nikuangalia hawa sasa walio wachache kwa sababu ata ikiwa wako wachache wako na nguvu kwa sababu ndio wako kwa serikali; tunaelewana? Sasa hiyo ndio muundo wa bunge ya Machakos kwa wakati huu.

Bunge zile zingine kama huko Central unawezakuta hakuna pande mbili kwa sababu walichagua watu wa Jubilee pekee; kwa hivo hakuna opposition na watu wote ni wa party moja. Sasa hapo shida ile inaingia ni kwamba nani ataangalia serikali ifanye kazi kwa sababu serikali lazima inaangaliwa kila wakati inaiywa oversight ndio ifanye kazi.

Sasa hapa nao mbele yangu mmeona watu watatu wamevaa nguo kama mimi; hao wanaitwa Clerks lakini kuko na yule main Clerk ambae ni wa bunge anaitwa Bw. Mbiuki ndiye anakaa hapo na hao wawili ni Clerk Assistants yaani wakumsaidia kwa sababu bunge ikiendelea hivi kila wakati imekua nikujandiliana nao procedure za bunge hawa ndio wamezisomea miaka mingi wanafaa kuongoza. Kwa hivo wanasedia Spika kuendesha bunge.

Na hapa unaona pako na wawili wamesimama; hawa wanaitwa Serjeants at Arms. Serjeant at Arms ni wale wanalinda usalama kwa bunge; sasa ikiwa kuna Mheshimiwa ambae ana-misbehave yaani ambae amekosa tabia kwa hivyo Spika akisema Serjeant at Arms, huyo mheshimiwa anatolewa nje ikiwa miguu hakanyagi vizuri vile askari wanashika mtu mshipi hapa alafu baadaye Spika anafanya kumuadhibu.

Kwa hivo kile nawaambia ni kwamba kwa bunge kuko na tabia, kukona discipline na hiyo inakua muhimu ndio bunge iweze kufanya kazi yake kwasababu ikiwa

hakuna discipline, nao hawawezi kuwakilisha wananchi kwa njia ile inafaa. Sasa nafikiri nimeshawaeleza hizi nguo mnaona ninavaa ndio zinaitwa official ya kuja Spika kuongoza bunge na bunge vile inaendeshwa iko karibu sana na korti na nyinyi mmeenda kortini na mmeona saa ingine ata mawakili wakivaa hizi; mimi pia ni wakili lakini hii navaa sai sio kwa sababu wakili lakini ni sababu ni Spika wa bunge ya Machakos.

Nafikiri sasa tumeelewana na tukona wengine staff wa bunge ambaa hii kitu mnaona hapa hii camera wakati huu tunaendelea kuongea mko live hata Kenya yote na dunia mzima. Mtaonyweshwa yule anataka vile mnaeza kuenda kwa simu yako sasa hivi ukiwa na simu smart phone kuko na ile page tuko kwa YouTube unaeza ku punch ama kudunda herufi fulani na uone kile kinaendelea saa hii lakini hata baadaye unaeza kwenda kuangalia. Naye yule anaendesha hicho kitu pia wanaitwa communications officer na ako na wengine wa kusaidia hapa staff wa Assembly wengi.

Kwa hivo assembly yetu ya Machakos imeendelea mpaka kiwango cha kufikia kwamba kile mnaenesha hapa saa hii kinaonekana live; ukiwa huko nje na ukiwa hapa ndani na ukiwa out of the country hata ukiwa London, ukiwa America unaeza kujua nini kinaendelea katika bunge la Machakos na hilo tulifanya ndio tuweze kuonyesha wananchi ni kazi gani tunafanya; hakuna kujificha sasa. Kwa hivo tunafaa wakati tunafanya kazi inatulazimu kubehave ama kuwa na tabia nzuri kwa sababu sasa uki-misbehave si unaonekana huko London? Haya asanteni wananchi.

Nimevunja sheria kwa sababu nilisema nitaweza kuongea na wananchi ambaa wako kwa gallery kabla ya tuondoke hapa ndio msibaki mkiuliza na hicho kitu ni nini na wale wanakaa hapo na wale wanasmama na nguo zile wanavaa ni za nini.
