COMMUNICATION FROM THE CHAIR

MINORITY COALITION MEETING

Members, pursuant to Standing Order No. 16, I am in receipt of a letter dated 17th April, 2014 forwarding minutes of Minority Coalition meeting held at the Assembly Conference Hall where Hon. Kasoa was duly elected as the Minority Leader of the County Assembly.

VOTER REGISTRATION

The second communication is on voter registration. I received a letter from Independent Electoral and Boundaries Commission (IEBC) dated 14th April, 2014 notifying us of the commission's plan to start continuous voter registration, an exercise that began on 15th April, 2014. The commission intends to focus on

- 1. Registration of eligible voters that previously registered as voters.
- 2. Transfer of registration of an already registered voter from a previous registration area to another registration area.
- 3. Removal of dead voters from the register.

- 4. Correction of voter particulars from an already registered voter who applies for such correction.
- 5. Public inspection of the register.
- 6. Capture of the biometrics of those missing.

This assembly, being an important stakeholder in public sensitization on key national issues, it is your duty as members to sensitize the electorate in your wards on this exercise which will be taking place in the IEBC's constituency offices during normal working hours, that is from 8 a.m. to 5 p.m. Therefore it is fair that you sensitize the public on this important exercise.
