APPROPRIATION BILL 2014 /2015

Hon. Chairman: You need to have the Bill with you so that you see the amount appropriated for each department in the year 2014/2015. I beg that you be patient, so that we can go very fast. Wait for the Bill to be circulated to you. Basically, I need to explain to you that this is actually what you passed in the main budget. After the budget committee presented its report, we found that in each department or ministry there was the total amounts both recurrent and development that were allocated.

So this is a summary of all the amounts per department that were allocated and this exercise, the passing of the Bill is actually to give authority to the Minister finance to appropriate those monies to the said departments so that they can begin to spend in the year 2014/2015.

I want to assure you it is not different if you have a copy of the summary budget that we passed here. You can also cross-check and you will find that the figures given or that you passed are the same figures that we have. So I welcome the Clerk to lead us.

REPORT AND THIRD READING

APPROPRIATION BILL 2014 /2015

Hon. Muinde: Mr. Speaker, Sir, I wish to report that the committee do report to the house its consideration of the Machakos County Appropriation Bill 2014 and its approval without amendment.

Hon. Manyolo: Mr. Speaker, Sir, one member is not properly dressed, that is Hon. Nzoka.

Hon. Speaker: I agree. Hon. Nzoka, kindly leave the chamber. (*Addressing Hon. Nzoka*) You are now out of order and you are discharged for one day.

(Hon. Nzoka withdrew from the chamber)

Order! Proceed.

Hon. Muinde: Mr. Speaker, I beg to move that the Machakos County Appropriation Bill 2014 be read for the third reading today the 26th June, 2014 and I call upon Hon. Rachel Nduku to support.

Hon. (Ms.) R. Nduku: Thank you, Mr. Speaker. I do support the Machakos County Appropriation Bill 2014 to be read for a third time. Thank you, Mr. Speaker, Sir.

(Question proposed)

(Question put and agreed to)

Hon. Speaker: May it then be read. The bill is now deemed as having been read for third time. I open the floor for debate. If there is no debate then, the mover of the Bill can address the assembly.

Hon. Muinde: Thank you, Mr. Speaker, Sir, and the House. I am very grateful to this House. More specifically this year in the budget-making process, going back to the last financial year, the process was not easy though we were all new into this assembly. This time round Mr. Speaker, I got all the support from all the members and your office and that of the Clerk and we are glad now we have a budget, now we have a Bill for 2014/2015 and I want to thank all our members and our staff who participated and want to say with the passage of the Bill today, tomorrow the office of the Governor or the Governor himself, will assent the Bill into a law. Since we cannot invite everyone, it is a small ceremony, the budget committee, the Majority and Minority Leaders are invited to witness a five minute ceremony of the assenting of the Bill into law. Thank you and God bless you.

Hon. Speaker: Then once again I hereby put the question that the Bill be now read a third time. Clerk kindly guide us on the long title.

(The Bill was accordingly read the Third Time and passed)

Now with that, then the Bill is now considered passed by this assembly. Thank you very much.

(Applause)

Any other matter? Hon. Members, that appears to be the last matter in the Order Paper, so next week on Tuesday through Wednesday, you all know that there will be vetting of our officers and all the relevant committees will be engaged for the entire week. Therefore, there will be no plenary sittings.

Now that a communication again was made to this House by the chair on the committee on Selection, I will urge there be a Liaison committee meeting on Monday so that the events of the balance of the week are planned. There are reports on the committee on agriculture, reports on the Agriculture Bill, Ward Development Bill and the Sand Harvesting Bill to be brought back to this house within seven days.

That will enable us plan how the business for the other week and this coming Friday, we shall have the entire House meeting to polish out the Strategic Plan. I think you all remember we were in Mombasa on it and we will have a meeting that will be communicated by the Clerk.

Finally, we are still continuing to receive messages of good will by our neighboring Speakers and county assemblies for those who were injured in the week. So the Strategic Plan meeting is Friday of next week.

RECAP ON EVENT OF GROSS DISORDER

So to summarize for those who were injured, we keep wishing you a quick recovery. I understand that the House is half full because some of you are still nursing their injuries including myself. But we shall look at it keenly, I don't know. I have had a meeting with Hon. Kyalo Kyuli and I can give him a minute to address the assembly on the events of the fracas.

Hon. Kyuli: Thank you. I did not expect to say anything on this but hon members; we need to have divergent views for the growth of debate in this particular house. Again, you need to look at me as a brother and if you hit me, as a brother, then we need to sit and talk and come together.

My appeal, when I call the Speaker, this is my own view that everybody saw what happened here. Everybody was involved because you and I were here. If I hit you, if you hit me, we were all here in this assembly and I want to say that I am not sent by anybody. I didn't talk to any other person apart from the Speaker. This is my feeling, that Mr. Speaker, when situations like this happen and the Speaker is the leader of this house, then it is time Mr. Speaker, you demonstrate leadership skill.

Because as a leader, I am sure you all know these leaders that you will be gauged on how you handled serious issues when they came and how they came. So my appeal, I was going to the Speaker, to appeal that in his own wisdom, whatever decision he takes, let him take a decision

that is geared to bringing the assembly together. If it is impossible, then that I cannot say and I don't know.

Hon. Speaker: So Hon. Kyalo Kyuli, just tell us, was it proper for members to get in with rotten eggs?

Hon. Kyuli: It was improper. So now, that is why I had to consult and give you personally on my own capacity and I will still if the room is there, still engage you if you allow.

Hon. Speaker: Thank you very much. A few comments on the event. I am not attracting debate, just......

Hon. Muinde: Mr. Speaker, I am not raising to add fuel to the fire. We all are very sorry for the events of that day but to imagine that a group could sit somewhere and plan to commit such a felony, a group made of men and women, with titles honorable is regrettable. We have gone out of functions, we are coming from Makutano right now and it is a national shame.

Leaders from Coast who addressed the function are saying this is not what they hear of Machakos. Without saying much, Mr. Speaker, I would have expected the Hon. Member whom you had given the opportunity to speak, to exonerate himself from that group because in many occasions, he sits with them and our wonder is, if he had sat with them, planned together and when he found that things are hot, he decided to conveniently absent himself.

I thought he would say, I am not part of that, I will never be part of that and I will always preach peace and be part of the peace caravan. Thank you.

Hon. Kalunde: Mr. Speaker and the entire house, I stand to say sorry to the people who were hurt by the members who have been all the times saying that, it seems this house has got hired terrorists. And of course, the hired ones where seen on that particular day.

So, it is wrong even for our brother who came here to say that he is sorry, because where the things where being organized, he was there with all those people who came in this hon house with bottles of beer. So Mr. Speaker, all I can say is that in an occasion like that one, those people should be condemned. I am not sparing any word and I do not mean them to be condemned for good. They have to come here, exonerate themselves from that behavior.

At the same time Mr. Speaker, when such a thing happens like what you saw hon. Nzoka here, he came purposely dressed in the way that he came, so that he can show his might from the person who has hired them.

At the same time, and I want Hon. Kyuli to understand this one, in the morning, one of the members of that group said that in the media, that there are only 13 people here who are remaining who have got brains. The others are just shells. So thank you, Mr. Speaker.

Hon. Speaker: Thank you. It is important we talk out.

Hon. (Ms.) V. Mbithe: Thank you Mr. Speaker and the entire house. I stand here, to say sorry to you and the rest of the members who were hurt. It is an indeed sad situation for such a house full of legislators who are law makers being the first ones to break the law. My opinion is, let the law take its course for the future, so that all the members may observe decorum in the house.

Hon. (Ms.) Mueni: Thank you Mr. Speaker, Sir. Mine is to say to you, sorry for what happened and to add on what hon. Kalunde has said. The way you see Hon. Nzoka has come, if we allow the other members to come like that, I don't think whether this house we will sit, because I was sitting here and I had to move to the back because he was ready for the fire.

Hon. (Ms.) Sereka: Kwa Spika na waheshimiwa wenzangu, yangu tu ni kusema ilikuwa ni aibu kubwa sababu wale watu tunategemea kwa hiyo group, kwanza wawili ni watumishi wa mungu. Ndio wangekuwa wanatuonyesha mapenzi vile tunakaa. Kama muheshimiwa mwenzangu anakaa hapa ni mtu anasimamia kanisa. Ni wale watu wanakaa mbele na wako karibu na Mungu na vitu zingine zikitendeka Bwana Spika unashindwa tunaenda wapi. Sababu kama mtumishi wa Mungu Yule mtu anasimama mbele ya watu na kuwaambia, hii ni mbaya, anakaa kwa watu fulani, wanapanga vile watakuja kuvamia wale wengine, kuumiza wale wengine, wanakuja hata na pombe na mahali kuna pombe. Mtumishi wa Mungu amekuwa mbali sana Bwana Spika.

Mimi ninaona hatua ichukuliwe, hii haikuwa kitu ya mchezo na hakuna kitu kama, upende ati kushikanisha kama ni mbaya wacha mamboiwe mbaya, Bwana Spika.

Hon. Speaker: Si ni huyo Mungu tu ndio anasema watu wasikizane, sio?

Hon. Nduva: Mr. Speaker, this event put us in the last number while we used to be number one in this country. It is not in terms of performance but in terms of conduct. Mr. Speaker, I regret and I think everybody of goodwill regretted that day because of the picture which was portrayed by our own hon members.

Mr. Speaker, I can remember, the stones and the rotten eggs where pointed at you. If now, the members who are fighting themselves, we could think of something else because we meet them in clubs and anywhere else.

But now the aim of what we saw here in this house, there must be a hidden agenda.

And what I would request from these hon. members, the Bible tells us to forgive each other. But those people, who had carried the rotten eggs and the stones and beer bottles, while forgiving them, let them face the..... (*Inaudible*). Thank you, Mr. Speaker.

Hon. Speaker: Thank you very much. I think that is about all. Ok.

Hon. Muli: Thank you Mr. Speaker. In fact the barbaric act which was done that day by hon members, sure enough it was terrible. Mr. Speaker, I would like to inform you that, the house is not yet in good mood. We are still in a fearful mood and also we need more security. In fact, the hon. member Mr. Nzoka---

Hon. Speaker: Hon Katela, I did not see you pass through the security checker. Kindly make sure he is checked.

Hon. Muli: Thank you Mr. Speaker, for recognizing that. Mr. Speaker, the hon member Mr. Nzoka, just as he want behind me, I felt the scent of beer, and I will like and request very sincerely, if there is a law or if we can make a law, which does not allow Hon. Members to enter in the chamber while they are drunk.

Most of the activities which they were doing here, it could not be done by normal people. It seems there was a catalyst of the actions or issue of drunkenness and also things which we could not imagine. Therefore, I request to be very tight as we enter the chamber. Thank you very much Mr. Speaker.

Hon. Speaker: Thank you very much. I think as we make the Speakers' Rules, we shall include that and we will find who to certify drunkenness.

Hon. (Ms.) R. Nduku: Asante Bw. Spika. Nataka kuchangia. Kwanza, mimi ni lihuzunika sana kuona wa mama kama mimi, wako katika ile jambo lilifanyika mahali hapa. Na mimi mwenyewe nilijaribu kuuliza mmoja wao na akaibuka na matusi.

Na Bw. Spika, nakuomba ukitoa uamuzi wako nakuomba kwa hisani yako tusiwasamehe tu hivi, kwa sababu ukiwasamehea tu, hatujui kwa sababu, tumeona uadui mkubwa sana katikati ya sisi. Na tukajua ya kwamba, kuna watu ambao wamejiandaa kuumiza wengine na kuleta madhara. Kwa hivyo Bw. Spika, ukitoa uamuzi wako nakuomba kwa hisani yako, sheria ichukuliwe ndio iwe mfano mzuri kwa wale wengine wanaweza kuwa na mipango kama hiyo siku zijazo. Asante Bw. Spika.

Hon. Kamitu: Thank you, Hon. Speaker. My contribution will go to what we call intentions. Hon. Speaker, we are talking of hon. members who carried eggs, bottles in the

handbags but kindly I would also want to tell you that apart from what was seen here, they had rungus, knives. It is not a hearsay, so the intentions where there.

Normally, when you prove intentions, it is like somebody maybe provoked by a word and if there is any fracas, it can be proved. This man was just provoked because he was abused but if we come to prove intentions, it is quite clear that these members had prior arrangements because we saw them returning *rungus* into their vehicles.

So, it is not a lesson that we are learning. We want to prevent a dangerous practice that maybe practiced in this assembly. And we are talking about hon, members. It is not a question. There should be no shortcuts in regard to people's safety. So because a crime was committed, let the State take its course and give us the way forward and especially to those people who were injured.

And my additional view is that, all people should be checked and again we should also add additional Sergeant At Arms in regard to gender. Because one of our Sergeant At Arms, that is Miriam, could not handle one of our lady hon. member who in fact is the one who started this fracas because by only refusing to take the order of a hon. Speaker and the Standing Orders are there and they are very clear. So, if we are going to follow procedures, the law should be followed to the note. That is my contribution, our hon Speaker.

Hon. A. Wambua: Thank you Mr Speaker. Kwanza niseme pole kwa wale waliumizwa. Na niseme huu ndio wakati mzuri wa kuona sheria ikifanya kazi. Kwa sababu wale walingonga zile dirisha kama wangekuwa wale vijana wa mtaani, saa hii wangekuwa huko ndani. Na wale walikuwa wakigonga pale saa hii hawako tayari kusema pole. Yangu ni kusema tuko tayari kuenda kuandikisha vile tuliona. Kwa sababu ilikuwa mpango mzuri, tutaanzia wapi na tutamalizia wapi na tutafanya nini.

Kwa hivyo, tuko tayari kuenda kuandikisha, na wale walionekana wakichukua viti, hio kiti haikuwa ikigonga ukuta. Ilikuwa ikigonga mtu. So this is the right time to see whether the constitution is there or it is not there. Thank you.

Hon. M. Mutuku: Thank you Speaker. Much has been said in line with what transpired and since this is a county assembly, to make rules and regulations to make laws, there is no way we can say 'let us negotiate' when it was a planned, when there was intention. If there was no intention, we can negotiate. Let us follow the due process of the law. Because we are making the law and there is no way we can actually violate the laws.

Over and above that, we have hon. members who were hurt and majority of them have filled P3 Forms and they have actually incurred expenses and I think the Speaker is one of the affected ones because I was not far. Even I was captured by the media, I saw myself in The Star. So basically, it is what really transpired that damaged the image of the Machakos, not only in Kenya but also in the international community.

Because, everything actually, it was circulated. It is a damage which will take us years before we repair it. So let everything follow the law the way it is. Thank you.

Hon. Katela: Thank you Mr. Speaker. I stand here to support my colleagues. In fact, it is a pity, because I saw a hon. member, a former chairman, breaking seats here. Those people should be surcharged and again that very good name of Machakos they brought to disrepute, Machakos county and Machakos Assembly, they should pay damages for it. I have just been called here by somebody from Meru. 'You are the one who was throwing those eggs.' Can we be paid damages for our otherwise former good name because now it has been damaged.

Hon. T. Kilonzo: Bw. Spika, yangu yatakuwa machache. Kwanza ni kusema, kama kuna kitendo mbaya ilifanywa ni hii. Maana nimekuwa kwa councils mara zaidi ya tat, na sijaona kitu kama hii. Na sisi hon. members hapa, tumekuwa tukisema sisi sio councillors, ati councilors ndio huwa wanapigana. Lakini hata sasa, tumekuwa hata chini ya counsillors. Na wacha niseme, hii vita haitaisha sababu jemedari bado ku-surrender. Hao wengine ni askari, lakini mwenye kuongoza jeshi haja-surrender.

Kwa hivyo hawa wachukuliwe ile hatua yeyote sasa hiyo sheria wanafuata na sisi tufuate, tuone ya kwamba wamefinywa kiasi ya kwamba sheria imefuatwa. Na wanasema ya kwamba wewe hujui sheria na kusema ukweli y Mungu, kwa hii town, Mung'ata hawezi kufika namba moja. Yake ni zaidi ya namba moja. Kusema ukweli, wale mawakili tuko na wao hapa. Kwa hivyo hii ni madharau kubwa na Bwana Spika mimi nakujua wewe ni mtu mpole. Hio upole wacha. Maana najua watakusanya wote wakuje kwako wakiwa watu sita, wajieleze vile walikuwa wanateswa halafu uanze kuwasamehe.

Sasa ,sisi tunasema hakuna kusamehea. Sheria ifuatwe. Kitu ile ingine nataka kusema, hii Assembly sasa vile tunashikana, hakuna kitu ya assembly inaweza kuanguka. Tuko na numbers, tuko na kila kitu, kwa hivyo hii kumbembelezana hatutaki. Tutasimama ngangari na sheria itafuatwa na tuta fanya kazi ya county na hakuna kitu itaanguka. Bwana Spika, unajua mimi nilikuwa nimelegea kiasi ya kwamba naenda naona kila moja namwambia hii maneno ni mbaya, tushirikiane, tufanye kazi pamoja. Mimi nimewaona, mpaka wenzangu pale wakaanza kuona ni kama niko kwa hiyo group.

Sababu nilikuwa nataka kuwaleta pamoja. Lakini sasa, sababu wamekataa, mimi sasa siwezi rudi nyuma, hata hii house yote ikirudi nyuma mimi naendelea. Asanteni.

Hon. Speaker: Thank you. I just want comments on what happened, not how the party intends to deal with its members.

Hon. Muthiani: Asante sana Bw. Spika. Nataka kuongea machache kuhusu hicho kitendo. Kusema kweli, kulingana na kiwango cha watu ambao wanaitwa waheshimiwa, hicho kitendo kilikuwa kibaya. Na kamwe, hatuwezi kuendelea kuvumilia mambo kama hayo.

Kwa hivyo nataka kusema ya kwamba, lazima sheria ifuatwe na lazima watu waonyeshwe ya kwamba hawastahili kuchukua sheriamikononi.

Na kumbuka ilikuwa mwaka jana tulipokuwa tunatembea huko Afrika Kusini, kuna mahali kulikuwa kumeandikwa na maandishi makubwa ya kwamba 'there is no mercy in Soweto.' Kwa hivyo Bw. Spika, I am telling you, and I am very honest, you should not sympathize with somebody who is not appreciating.

Kwa hivyo hata ukifanya nini, hawa watu hawataacha hiyo tabia. Kwa hivo na kuuliza nanasihi hawa members wote, tuunge mkono jambo lolote la kuhakikisha ya kwamba hawa watu wamechukuliwa sheria ambayo inafaa. So, Mr. Speaker, Hon. Timothy has said, please don't be lenient, and don't be very soft.

Tukiendelea hivyo, kesho itakuwa ni mimi, the day after tomorrow, itakuwa my labor chairman. Kwa hivyo ni lazima tuhakikishe ya kwamba haya mambo tunaangamiza at this early stage. Shukrani sana Bw. Spika.

Hon. Speaker: Thank you very much. That was elaborate.

Hon. Nzeki: Thank you, Mr. Speaker, Sir. I wanted to contribute about what happened yesterday and I wonder how somebody waited for 28 days until the egg could not hatch. That is why I am saying it was an organized terror attack.

Way forward, I am about to bring a motion, for hon. members who are ladies that they be searched and the bags be left outside because in most of the bags, they carried the bottles with urine. That is why you found it was smelly. It was urine it was not beer. Kwa hivyo mimi naomba Spika tuongeze another lady who is a security officer in this house. Thank you.

Hon. Speaker: I don't want to believe that but I will take it in. So the content was actually different?

Hon. Nzioki: Asante Bw. Spika, langu ningependa kusema, jambo ambalo lilitendeka hapa, lilikuwani la aibu sana. Na kama vile waheshimiwa walivyo sema

Na kama vile waheshimiwa walivyo sema, Mheshimiwa Kyuli ambaye ni rafiki yangu sana na tulicheza mpira naye tukiwa wachanga, hata siku aliposimama, sikusikia akisema kama anaomba msamaha, amepitia tu huko kando kando na akasema tushikanishwe pamoja ili tusameheane. Bw. Spika, mimi ningeomba na ningetaka kuhimiza ya kwamba wakati huu, sio wakati wa msamaha.

Kwa sababu kile kilichotendeka hapa, ni kama vile mtu anakutupia mshale na ule mshale ukikundunga hapa anakwambia pole, 'sio wewe nilikuwa natupia mshale.' So what we are saying is Bw. Spika? Tusisameheane, tusameheane kwa sheria na mambo yataenda vizuri. Asante.

Hon. (Ms.) Ndumi: Thank you Mr. Speaker, Sir. What I want to say, what happened that day, it was not good and again we were not prepared whether they are coming to fight. And if we were prepared, you can see we are bouncers here in the house. The other thing Mr. Speaker, Sir, if it were not me, I think your children would be crying. I was your security that day and I think after we finish this, I will give you my bills so that you can pay me. I protected you, so much all the eggs were on me. Even the Majority Leader, I am also sending my bills to him. Thank you Mr. Speaker, Sir.

Hon. Speaker: Thank you very much for being a gift to the assembly. We appreciate you.

Hon. (Ms.) Nina Mbithe (Nominated member): Bw. Spika, mimi rika yangu sio kama ya hawa wengine. Yangu imeenda kidogo Bw. Spika. Bw. Spika, siku ile, mimi niliumia lakin sikujua kama niliumia. Siku ile nilienda nyumbani ndio niligundua mgongo wangu umepigwa. Na sikujua nikitoka hapa. Bw. Spika, kile nataka kuongea saa hii hawa kina mama unaona hapa, wacha niwaite hivyo, kwa sababu wanatulinda huko nyumbani, tunalinda nyinyi wanaume huko nyumbani na nyinyi ni waheshimiwa pia, wako na makosa kubwa.

Inataka tukae chini sisi wamama peke yetu tuongee kimama, tuongee heshima ya wanawake. Sababu Bw. Spika, wengine wako na wajukuu kama mimi. Usione ni kama watoto kwa sababu wanava jeans hapa. Hao ni wamama wazee mbele.

Na wale wanakunywa hapa Bw. Spika, wanabeba hii vyondo ikiwa na pombe, ni wamama wako na wajukuu wakubwa sana. Mr. Speaker, ni aibu kubwa sana tukiwa huko nje, wamama wakisemekana ati walikuwa wamebeba pombe hapa. Kile kinatakikana nikuheshimiana na wahimizwe hawa na akili. Huwezi kuingia kwa assembly ukiwa umelewa. Mimi nimekuwa Municipal kwa miaka tano na sikuona kitu ya aina hiyo.

Mr. Speaker, na wale wengine wanajigamba mabwana zao ni polisi, sisi hatujui polisi hapa assembly. Tunajua ni mheshimiwa amekuja kama Yule mwingine. Bw. Spika, kama wanagojea mabwana zao wawatetee, sisi hio, sheria iendelee. Mr. Speaker, wewe uko na akili. Tumia hiyo akili kubwa sana tuone hawawatu vile tutafanya. Bw. Spika, ukiona vile asubuhi niliona K24, Mhehsimiwa Dominic akiongeana, Mheshimiwa Muthuka akiongea. Nimekasirika sana. Hata hawatupei heshima, hata sijui walichaguliwa na nani.

Nataka uni-guide iliniandike statement ama nisiandike....hii mgongo yangu imeumia. Na maisha yangu si kama ya hawa watu Bwana Spika. Nikiumia nikiwa namna hii na ni mimi najitegemea Mr. Speaker. Mr. Speaker, nataka hatua ichukuliwe, kwa hao wanawake, sana sana Yule alikuwa anabeba chupa.

Ile ingine nataka kuambia Hon. Kyuli. Mr. Kyuli, siku moja nilikuwa mgonjwa sana na ukakuja kwa kitanda yangu kuniangalia na ulikuwa unawekewa chai ukiwa kwa kitanda yangu.

Sikua napumua, roho inapiga. Na ile kitanda yangu ulikalia. Hiyo ni laana kubwa sana. Laana ambayo haijanonekana.

Bw. Spika ukipitisha hii, watu waombe msamaha kwasababu sijui nani alinionga. Pengine ni Mheshimiwa Kitheka kwa sababu nilikuwa karibu na yeye. Bw. Spika usione ni kama mchezo. Tangu jana nilimwambia Mheshimiwa Cecilia na waheshimiwa wananwake wote. Kuwauliza sasa nitafanya nini. Niliumia. Kwa hivyo wewe Mheshimiwa Kyuli, tukimaliza hii, anione kando aombe msamaha. Kukalia kitanda yanu ni laana na kuja kupigana kwa hii kitu. Na akifanya hivyo, ataendelea vizuri. Asante Bw. Spika. Yangu ni hayo.

Hon. Speaker: Okay. Finally.

Hon. Sila: Bw. Spika, mengi yamesemwa---

Hon. Speaker: Order. Finally.

Hon. Sila: Mimi ni mmoja wa wale waliumizwa. Mmeona kwa media Mheshimiwa Muthuka akiwa ameshika kiti na kitambo tufike pale alikuwa amenigonga kwa kichwa. Na mimi nilienda kuchukua ripoti na nikachukua barua ya kwenda hospitali. Mimi ni lazima nitafuata sheria to the letter kwa maana mimi niliumizwa. Kichwa, kifua hata mguu niko na kidonda.

Hon. Speaker: Pole sana.

Hon. Sila: Mimi nasema asante sana kwa maana nimeona mnalia pamoja na mimi na lazima tufuate sheria. Mimi sitaachilia mtu alijaributhey had a set mind to kill. Mimi nilikuwa pale nje wakati ambapo nilivuka ile maua nikaona Mheshimiwa Anne akichukua mawe na ni yeye pia alikuwa na soda kwa sababu nilikuwa nimekaribiana naye nje na ile mayai.

Mr .Spika hatuwezi kukubalia mtu wa aina hiyo, kamwe, kwa kauli moja. Hiyo watu tutoe nje. Naomba tushikane pamoja, tuseme hio dhambi yote tuondoe nje. Sijui kama mnakubaliana na mimi jameni.
