**Hon. Kasimu:** Mr. Speaker, Sir, I stand under Standing Order number 41(2a) where during the statement hour, a member of the House Business committee designated by the committee for the purpose shall every Thursday on the last sitting day, for not more than ten minutes, present and lay on the table a statement of information of the House Business committees' business coming before the House in the following week.

Mr. Speaker, Sir, the House Business committee met today, October  $29^{th}$  2015 and balloted business for the following week as follows: -

- Tuesday afternoon 3<sup>rd</sup> November 2015 report of Liaison committee on committee progress reports
- Wednesday morning, 4<sup>th</sup> November 2015 report of Environment, Land Energy and Natural Resources committee on status of pollution in River Athi at Fourteen falls and its environs.
- Wednesday afternoon, 4<sup>th</sup> November 2015 report of Budget and Appropriation committee on benchmarking tour to Kiambu and Nakuru Counties and Machakos County Administrative Structure Bill, 2015, second reading.
- Thursday afternoon 5<sup>th</sup> November 2015 projects implemented in 2013/2014, 2014/2015 and 2015/2016 debate. Thank you. Mr. Speaker.

# Hon. Temporary Deputy Speaker: Thank you.

**Hon.** Maitha: Mr. Speaker, with your permission I was not listed in the statements but I would like to put to your awareness Mr. Speaker that I sought some statements a while back about three, four weeks ago. It was directed by the Speaker that those statements should be responded back and answers given within fourteen days. To date Mr. Speaker, there is no statement that has been responded. I wonder what the relevant chairs are doing. I wonder whether they are obeying the directions of the Speaker, because there is no statement that has been given out.

Mr. Speaker, responsible chairpersons for various committees need to understand that whenever a statement has been sought, it is sought as a matter of urgency so when it takes about a month, two months before you respond to that statement, then those people or the beneficiaries who are meant to benefit from the answers of that statement are denied their constitutional right.

Mr. Speaker, I wish to request you to make a decision on that because when we seek for statements, we do not seek statements to wait; those are matters of urgency and actually some statements need to be responded to within seven days. It is now more than a month and there is no single statement that has been responded to. Can you guide on that, Mr. Speaker. Thank you.

**Hon. Temporary Deputy Speaker**: Thank you Hon. Member. I would request if maybe you can mention some of the statements that you sought which were not responded to.

**Hon. Maitha**: Mr. Speaker, I think the statements were about ten that I sought and one statement was about the issue of education which I was invited in a committee the day before yesterday and the chairman of education was supposed to get some documentation to respond to the same. I have not gotten any response from that.

There was a status report on implementation of projects. There was also a statement about why the County Public Service Board has not issued staff or those casuals who have been engaged for the last two years with employment letters. There was a statement about why the department of education has not accomplished ECD classrooms that it promised to do so among many others that I cannot remember off head.

If out of ten none has been responded to and it is a month and those are basic requirements that we are denying our people the rights, then I think Mr. Speaker we are not taking the statement hour in this House as a serious issue. I think Mr. Speaker, guided by the precedence in the National Assembly, I do not know whether some Hon. Members here tried to follow proceedings in the National Assembly and see the manner in which some of these issues are undertaken.

Whenever a statement has been issued or has been requested for Mr. Speaker, it is responded immediately and the relevant sectoral committee sits down immediately and gives a response to the effect. Our Speaker rules that a statement be issued within seven days then it is forgotten; it is not followed up Mr. Speaker, sir. I think we need guidance on this because we are really not taking statements as a serious issue. Thank you Mr. Speaker, sir.

Hon. Temporary Deputy Speaker: Maybe before we proceed Hon. Member I will be able to respond on the issue of statements at the end of the statements hour simply because I understand there are statements which are slotted. It is the statement hour and I expect statements will be coming up. There may be some chairpersons like we have a statement which will be responded to concerning status report on implementation of projects, among others. If you will not be contented maybe later I will give direction on the same. Clerk proceed. Yes point of order.

### POINT OF ORDER

**Hon. Muthuka**: Thank you Mr. Speaker, Sir, and the rest of the House. Mr. Speaker, I think we should live by the rules of this Assembly. For one to bring a statement here, he must have supplied the person who requested the statement two hours before the start of the session. If you are alluding that there are statements which are coming to this House, I think that is unprocedural. Let us observe the rules of the House. Thank you.

**Hon. Temporary Deputy Speaker:** Point of order valid. I will be giving directions at the end of the statements. Clerk, proceed.

#### **STATEMENTS**

**Hon. Kasimu:** Mr. Speaker, Sir, on Wednesday 30<sup>th</sup> September, 2015, Hon. Felix Ngui stood under Standing Order number 227 and moved a motion requesting the Hon. House to suspend its business for one week to discuss the state of El-Nino preparedness and also projects implemented by the county government since 2013. The Hon. Speaker directed that the Majority Leader prepares and issues a statement on the matters raised so that they could form a basis for debate in this Hon House. So far a statement on El-Nino preparedness has been issued and members should proceed and interrogate it.

On the projects implemented Mr. Speaker, Sir, the Clerk of the County Assembly wrote to all 16 chief officers in the ten departments. The Assembly had received reports from eight Chief

Officers by 27<sup>th</sup> October 2015 and the reports had been analyzed and are the subject of today's statement of projects implemented since 2013. Mr. Speaker, sir, three other departments brought their reports after Monday, 27<sup>th</sup> October 2015 and were in the process of being analyzed and will be ready next week for tabling. Mr. Speaker, sir, the following five Chief Officers were yet to respond to the reminder written by the office of the Clerk to submit their reports:

- Public works and housing
- Irrigation
- Agriculture, livestock and fisheries.
- Health, environment, emergency services.
- Special programs and projects.

Mr. Speaker, Sir, the reports that were received after Monday, 27<sup>th</sup> October 2015 and were in the process of being analyzed were from the Chief Officer Roads, Transport Tourism, Sports and Culture and Finance and Revenue Collection.

Mr. Speaker, Sir, analysis had been done for reports from the following Department:-

- 1. Trade, Economic Planning, Investment and Industrialization
- 2. Public Service, Labour and ICT
- 3. Cooperative Development and Marketing
- 4. Water
- 5. Lands and Urban Development
- 6. Education, Youth and Social Welfare
- 7. Decentralized and County Administration
- 8. Energy and Natural Resources

Mr. Speaker, sir, analysis of the above Departments is as follows:-

# **Department of Water, Irrigation and Sanitation**

Mr. Speaker, Sir, the department of Water implemented 51 projects since 2013. The Department implemented 38 projects in the Financial Year 2013/2014 mostly on ground water survey, works on boreholes and supply of water to various points. In addition, during the financial year the Department undertook rain harvesting initiative by supplying 986 water tanks to primary schools. The Ministry also supported various water boards such as KAMWASCO, MAWASCO, MWASCO, YAWASCO and MAVWASCO to improve water provision to residents. Most of these projects involved a number of stages and the first and second stages in majority of them were complete.

Mr. Speaker, Sir, in the financial year 2014/15, the Department undertook to implement 7 projects. The landmark projects in this financial were water mapping which was completed, hydrological survey which was ongoing in all wards as well as dam construction which were complete and village based water in all wards which were ongoing.

Mr. Speaker, Sir, in the financial year 2015/16, the Department undertook 6 projects and all of them are ongoing. These projects include installation of solar and electric water pumps to boreholes in all sub counties, drilling of boreholes and laying of pipes and construction and desilting of earth dams.

Mr. Speaker, Sir, the department included the contract sum and the actual expenditures in their report. A summary of the projects is provided below for further information.

# **Department of Decentralized Units and County Administration**

Mr. Speaker, Sir, in the financial year 2013/14 the Department of Decentralized Units and County Administration undertook 20 projects. All the projects were completed except one on construction of culverts and drainage system. The projects undertaken to completion include fencing of markets and cattle yards, purchase of communication equipment for security, purchase tippers for solid waste management, construction of dog cages, purchase of dogs, CCTV installation, installation of metal barriers at the stadium, purchase of hand held detectors, installation walk through metal detectors, renovation of inspectorate radio house, procurement of boat to be used for rescue in Maruba Dam, construction of public toilets, construction of Mlolongo bus park, tree planting along Mombasa road in Mlolongo, Mlolongo Modernization of Mlolongo town parking spaces, Construction culverts and drainage system in Mlolongo, acquiring of skip bins, construction of 2 at Kamulu Secondary School and construction of Ngelani pit latrine in Masinga.

Mr. Speaker, Sir, the department did not show the cost of the projects and also did not provide projects undertaken in 2014/15 and 2015/16 financial years. Presumably, the Department did not undertake any projects in the said financial years. The summary of the projects undertaken is provided below:-

# **Department of Public Service, Labour and ICT**

Mr. Speaker, Sir, in the financial year 2013/14, the Department of Public Service, Labour and ICT undertook 4 projects all of which they completed. These projects were: internet and network connectivity (local area network – LAN and wide area network – WAN); upgrading of server room to host business systems; setting up of county website; and setup of call centers for emergency response. The cost of these projects was not shown.

Mr. Speaker, Sir, in the financial year 2014/15, the Department implemented 6 projects to completion namely: Asset management system to track county assets; Local Area Network connectivity to offices of the Decentralized Department, County Legal Office, County HQs and Social Welfare Offices; wireless network connectivity to County HQ; mounting of call center screens; setting up of e-mails for staff; and furnishing offices with furniture.

The department did CCTV installation in 10 locations and did not show whether the projects were complete or not. In addition the Department undertook to establish a Mortgage and Car Loan Fund scheme for its staff and was still ongoing. Most of the projects undertaken in the financial year had their costs shown.

Mr. Speaker, Sir, in the financial year 2015/16, the Department undertook 4 projects and completed one namely: staff training on CCTV maintenance. Two projects had started and were ongoing and they are relocation of CCTV control rooms in Kithimani, Mlolongo and Wamunyu to police stations and electricity supply to CCTVs along Joska-Kangundo road. The state of the fourth project (CCTV installation at Public Works Parking Ground/Show Ground/Kithini Road Barrier) was not disclosed. Costs of these projects were shown.

Mr. Speaker, Sir, in the financial year 2013/14, 2014/15 and 2015/16, the Department of Cooperative Development was not allocated any funds for development and as such it did not undertake any projects. In total the Ministry of Public Service, Labour, ICT and Cooperative Development undertook 15 projects as summarized below:-

# **Department of Education, Youth and Social Welfare**

Mr. Speaker, Sir, the Department of Education Youth and Social Welfare undertook 28 projects in the 2013/14, 2014/15 and 2015/16 financial years as follows:-

In 2013/14, the Department implemented 5 projects fully namely: Trial Exams for class 8 and form 4, ECDE feeding, Feeding class 8 and form 4 candidates, installation of backup

generator, renovation and sound proofing of offices for Executive Committee Member, Chief Officer and Boardroom and equipping library with furniture for Machakos Youth center.

Mr. Speaker, Sir, in 2013/14, Bursaries were given partially at Kshs. 50 million with the balance of Kshs. 30 million remaining undisbursed up to date. Construction of youth centers was also partly done with Machakos complete and Mavoko at 80 per cent complete up to date. The other projects planned for the financial year namely lap – desks and psychomotor materials were implemented up to procurement stage.

Mr. Speaker, Sir, in 2014/15 financial year, 13 projects were implemented fully. These projects were: Bursaries, Trial exams, feeding of candidates, lap – desks, psychomotor materials, training of youth polytechnic managers and instructors, issuing of Kidsmart computers to 60 ECDEs, training youth on ICT (Vusha Project), groups profiling (youth groups, women groups...), Partnership with Sweden's Robertsfors, visitation of 8 children homes, identified 8 day care centers for elderly in health facilities and disbursement of Kshs. 20 million for the elderly.

In 2014/15 financial year, 8 projects were not completed and they include: Construction of ECDE classes whereby 33 were completed, 30 are ongoing and 15 had their contracts terminated; construction of Youth Centers in Kangundo was completed, Matungulu was at 70 per cent and Athi river at 80 per cent; provision of 40 wheel chairs and white canes to persons with disability was at procurement stage; disbursement of Kshs. 20 million to women to be done in one weeks' time; sensitization of public on Gender based Violence was on going; development of talent in youth by equipping music recording studios was at budgeting stage for next financial year; training of class 8 and form 4 dropouts on hospitality, mechanic, driving and carpentry was on going; and conducting Quality Assurance and Standards in Youth Polytechnics was also on going.

Mr. Speaker, Sir, in 2015/16 financial year; 2 projects were complete and 3 were at tendering and procurement stages. The Department had completed projects on Trial exams and Feeding of Candidates. 30 ECDE classes had the process of open tendering initiated. Procurement process of Educational aids, ECDE texts to 1067 ECDE centers and geometrical sets was complete and extension of office at the Headquarters was complete.

Mr. Speaker, Sir, the Department did not show the cost of the project. A summary of the projects is shown below:-

# **Department Of Trade, Economic Planning, Investment And Industrialization**

Mr. Speaker, Sir, In the financial 2013/14, the Department undertook to implement 4 projects and managed to complete only 2 namely purchase of motor vehicle and renovation of the offices of the CEC member and the Chief Officer. The other two projects did not start, only procurement process was completed. These were construction of a market shed and a public toilet in each ward except Machakos Central Ward and purchase of 2 jaw crushers for Ikombe and Katangi wards. The state of Mavoko trade offices was not stated.

Mr. Speaker, Sir, in the financial year 2014/15, the Department had only one new project namely purchase of a motor vehicle. The other three projects were work in progress carried over from the previous financial year 2013/14. The Department managed to partition the ground floor of Mavoko trade offices. Jaw Crushers were earmarked to cost Kshs. 9,100,000 but have not been delivered. Construction of Market Sheds was as follows: 35 market sheds have been reported as on-going and 4 not started namely: Ikalaasa, Kikambuani, Tala and Kibauni.

Mr. Speaker, Sir, the cost of each project has been provided by the department as well as amount that has already been spent in some of the projects especially the market sheds and Mavoko trade offices. This expenditure can be seen in the report from the department. Further, the Department did not provide information on what it was undertaking in the current financial year 2015/16. A summary of the projects is provided below:-

Members, you realize it is a lengthy statement and I understand it is the wish of every Member to be given time you go through it and I direct that Members be provided with copies then we will be able to maybe debate on that statement on Wednesday in the morning session. Proceed.

### **MOTION**

#### REPORT ON KISUMU BENCHMARKING TOUR

**Hon. A. Wambua:** Thank you, Mr. Speaker. I wish to defer this report of the Implementation Committee to table it on Wednesday, 4<sup>th</sup> November, 2015 during the first plenary because in the report there are touchy issues which the committee wishes the Speaker and the leadership of the House must be present to shed light on some issues. I call upon Hon.Dominic to second the report.

**Hon. Maitha:** Thank you, Mr. Speaker and my able Chairperson Hon. Alphonse Wambua. Mr. Speaker, Sir, I stand to second the request for deferral by my able Chairperson Hon. Alphonse that we discuss this report next week. For those who are clapping I wish to overemphasize my able Chairperson among others.

# (Applause)

Mr. Speaker, why I second this deferral is that the purpose of bringing reports in this Hon. House is to ensure that every Member is given a chance to participate fully, both materially and ideologically. This report is very crucial and some of the questions that have been asked of the Implementation Committee will be answered through the report that we are going to give. I support the deferral of the report 100 per cent and we discuss it next week and request Hon. Members and especially the leadership to be present so that those questions that have been asked since time immemorial be answered that day. The presence of each and every Member is eminent on that day. Thank you Mr. Speaker, Sir.

**Hon. Temporary Deputy Speaker:** Thank you but before I grant the permission, I think the reason that you are giving is not sufficient. We have the Leader of the Minority, we have the Deputy Minority and at any given time, the House cannot adjourn a motion because maybe some people are not in the House. That means if they are not present, we will not hear that motion. Chairperson?

**Hon. A. Wambua:** Thank you Mr. Speaker. You are aware that there are some Members who are on official duty in Ethiopia and it was the wish of the committee Members that all the Members of this House be present that day. Thank you.

Hon. Temporary Deputy Speaker: Permission granted. Clerk, proceed.

(Clerk consults Chair)

Hon. Members, sometime back a statement was tabled before this House. The statement was on El-Nino preparedness and implementation of the project. On the part of the implementation committee, I have given direction that the debate will be conducted next week on Wednesday in the morning session but I now open the floor for debate on the El-Nino preparedness. There was that statement which was circulated last week and now I open the floor for Members to contribute on El-Nino preparedness.

#### **STATEMENT**

EL - NINO PREPAREDNESS (EXPOSITION AND DEBATE)

Hon. Temporary Deputy Speaker: Yes, Hon.Dominic Maitha.

**Hon. Maitha:** Mr. Speaker, you are putting these Hon. Members in a state of quagmire because when you tell us to discuss a report that we do not even have copies, a report that does not even appear on the Order Paper, Mr. Speaker, Sir, I think you are putting this House in an awkward situation Mr. Speaker if I may say because this statement was sought by one Hon. Ngui; he is not even in the House, Mr. Speaker, Sir. If we discuss this report, whose details we do not even have, we might be discussing a document which we have no information about.

Mr. Speaker, even if you push the debate to next week, I do not think whether our discussion today and next week will change the way *El-Nino* is supposed to rain or the preparedness which was supposed to be there. I think Mr. Speaker with your guidance, it will be prudent enough that we can give that room that Wednesday next week or Tuesday afternoon next week, we can discuss that report in the presence of whoever sought the statement and even be able to be supplied with the documentation, the statutory report of that statement, so that we can go and peruse through and then come and debate about it.

Otherwise, when we debate about it, for example the only thing I can remember about that report is the County said it will spend Kshs. 300 million. Beyond there I know nothing. What am I going to be debating about? Thank you, Mr. Speaker, Sir.

**Hon. Temporary Deputy Speaker:** Maybe we would like to know, does this mean the Order Paper does not have statement on the *El-Nino* preparedness? Is there number nine? ...and again maybe for information Hon. Member, copies of the statement were circulated sometime back. I don't know the feeling of the other Members. Hon. Deputy Majority Leader.

**Hon. Kasimu:** Mr. Speaker, Sir, a statement was properly laid before the House. The Speaker ordered that the papers be distributed on Tuesday the 27<sup>th</sup> and the papers were distributed to all the Members. It is now the Members to ask questions and maybe comment on the issue, Mr.

Speaker, Sir. Mr. Speaker, it has been a culture of the Members of this House to get reports, to get statements, and just dump them in the boots of their car. That is why they are surprised when they hear it is time to discuss this statement. Mr. Speaker, Sir, I want you to ask the Members to go for the statements if they do not have them here or they be issued with fresh ones. Thank you, Mr. Speaker.

### Hon. Temporary Deputy Speaker: Hon. Kitheka, I can see you want to say something.

**Hon. Kitheka:** Mr. Speaker, for the betterment of the execution of the functions of this House, we have gotten the statements; we have gotten the copies and I think it will be prudent enough for us to discuss the document if need be because even if we postpone the entire process of discussing the document, it will not make sense. We better discuss at this particular moment when the onset of the rains is not completely on the grounds. So, I hope we discuss the document. Thank you.

# **Hon. Temporary Deputy Speaker:** Hon. Festus Ndeto.

**Hon. Ndeto:** Thank you, Mr. Speaker for the opportunity to contribute over this statement. There is a lot that we need to know as far as this issue is concerned. One, in each of the 47 counties, there were reports taken to the National Government both from the County and the National Government. Here in Machakos both the County Government and the National Government met, they agreed to come up with one document which the County Commissioner is responsible.

We need to know as we go on with this, with him being the Chairperson of that meeting and committee, how do these two merge? The County Government whereby we have given the Kshs.300 million and whatever is being contributed form the National Government. Mr. Speaker I would kindly request if we can adjourn or postpone this discussion to another date in which Members will have gotten more information over the same and at the same time we go and study what is given to us today. Thank you.

### Hon. Temporary Deputy Speaker: Hon. Mutuku

**Hon. M. Mutuku:** Thank you Mr. Speaker, Sir. I wish to echo the sentiments of Hon. Ndeto that if we can postpone the matter before this Hon. House, then we discuss it at length, next week, once the Hon. Members go through the purported report which we have, I think it will be in the interest of the Hon. Members, at least, because for now, debating it when we are receiving just only one piece report (???). Over and above that, we understand all of us that there are rumours that the National Government has set some money for *El-Nino* preparedness and we are hoping the County should do the same. Therefore, Mr. Speaker, I wish to request if we can defer the matter for next. Thank you.

**Hon. Temporary Deputy Speaker:** Yes, what is the point of order Hon. Stephen Muthuka?

#### POINT OF ORDER

**Hon. Muthuka:** Thank you Mr. Speaker, Sir. Mr. Speaker, going through this statement, there is nothing to discuss here. This is not about *El-Nino* because this is part of the money that we set aside for water. So, building weirs is not *El-Nino*. There is nothing like emergency here. Mr. Speaker, can this House get a report on *El-Nino* preparedness because we are talking about Kshs.300 million from our budget...

**Hon.** Temporary Deputy Speaker: Order, order Hon. Member. You are out of order. There is an issue that has been raised by Members concerning adjournment. Maybe now you are guided; you can comment from there.

Hon. Muthuka: I am in line with that.

Hon. Temporary Deputy Speaker: Protected. Proceed.

**Hon. Muthuka:** That is why I am saying we do not need to discuss this. We need to adjourn and by the time we come back we need a comprehensive statement on the preparedness, not the expenditure of how we are going to spend Kshs.300 million from the water budget making weirs. Weirs, that is normal; it is part of our program so that we can ensure that each house has tapped water by 2016. That is not part of *El-Nino*. Mr. Speaker, let us get the right statement towards the preparedness of the awaited *El-Nino* if at all it will be there.

**Hon. Temporary Deputy Speaker:** Hon. Members do you have any opposing position? You are opposing that we adjourn? Yes, Hon. Benedette Mueni.

**Hon.** (Ms.) Mueni: Thank you, Mr. Speaker, Sir. I think our Members who are going outside are not serious with this Assembly because the *El-Nino* is not waiting. I think over this weekend we are waiting for that *El-Nino* but because I can see the mood of the House is that the people are not willing to discuss about it, we can adjourn and I think you must be serious with the people who sent you here. You are paid and you are going outside. Why? Thank you.

Hon. Temporary Deputy Speaker: Hon. Members without much ado, I can see we are all in consensus that we defer the discussion of this motion to next week. I direct that we discuss it next week, Wednesday, in the morning session. Before we leave there are issues which have been raised by Hon. Dominic Maitha concerning some chairpersons not giving you statements as required within the stipulated time. I direct the statements which were sought by the Hon. Member and other Hon. Members that by next week, they should be within the House. Leader of Minority you can take up that task, communicate to the relevant Chairpersons that they supply the House with the relevant responses concerning that.
