MOTIONS

STATUS OF KANGUNDO LEVEL IV HOSPITAL AND HEALTH FACILITIES IN THE SUB-COUNTY

(Hon. Kyalo Kyuli on 30.03.2016)

(Resumption of Debate on the Motion tabled on 24.03.2016)

Hon. (Ms.) Sereka: Health and Emergency Services Committee report on the status of Kangundo level four hospital and the rural health facilities in Kangundo Sub County. Mr. Speaker, Sir, Article 43 (1) (a) of the constitution of Kenya 2010, states that every person has the right to the highest attained standard of health which includes the right of health and care services including reproductive health care.

The Health and Emergency Services committee received a public outcry in poor status of Kangundo level IV hospital and the rural facilities in the sub county through the area Member of the County Assembly. Pursuant to Standing Order 190 (5) (c) on the function of sectoral committees, the functions of a sectoral committee shall be to investigate and enquire---

Hon. Speaker: Sorry, Hon. Cecilia. I remember perhaps when this matter was presented by your brother Hon. Kyalo Kyuli who is currently disposed, this report was fed through to Members and today it was shelved for debate. The expectation of the House is that you now deliver on debate and arguments in support of your report, kindly.

Hon. (Ms.) Sereka: Thank you Mr. Speaker. It was just a refresher; I know some of the Members do not have the report but I want to ask Members, kindly support this report. This report is for the benefit of our people from Kangundo and not only Kangundo, but the surrounding sub counties. So Members, I urge you kindly to please support this motion. Thank you, Mr. Speaker.

Hon. Speaker: Thank you. Members you have been urged to kindly support the motion so I welcome your contributions. Hon. Willy Kasimu you can begin... Yes?

Majority Leader (**Hon. Mwonga**): Mr. Speaker, with the leave of the House and the Chair of that Committee, that is Hon. Cecilia Sereka, I understand His Excellency the Governor visited Kangundo Level IV Hospital about two days ago and as a Leader of Majority, I will be in an awkward position when responding to this report. With the leave of the House, I want to suggest that this report be deferred so that, I can(inaudible) the motion on what transpired when His Excellency the Governor Machakos County visited Kangundo level IV. Thank you, Mr. Speaker.

Hon. Speaker: I think those in support of that preposition maybe I can get somebody in support of the adjournment. Yes, Hon. Munyaka.

Hon. Nzeki: Thank you Mr. Speaker, Sir. I concur with my Majority Leader because the Governor sometimes this week visited Kangundo and I understand yesterday very late, he met with his cabinet and people are going to be employed. The doctors, nurses, lab technicians are going to be employed and since the Majority Leader has asked for a leave to know from the Governor, I will support that we wait until he gets enough information. Thank you Mr. Speaker, sir.

Hon. Speaker: Then debate will be deferred but not until we hear the Hon. Member for Mayoko.

Hon. M. Mutuku: Thank you Mr. Speaker, Sir, for granting me the opportunity. I would like to express the same sentiment as the Hon. Members and also to add as I look at the whole House, three quarters of the Members as of now do not have the report with them and it will be a challenge for them especially when they are making their contribution. In line with that Mr. Speaker, sir, I wish to second for the deferral of the report until we get to hear what the Governor recommended and we also get the same reports from the Members referred to. Thank you.

Hon. Speaker: Thank you, I think with that I proceed to put the question that the report be deferred.
