MOTION

AD-HOC COMMITTEE REPORT ON CONDUCT OF CPSB SECRETARY

Hon. Ngunzi: The motion that I have today has a constitutional requirement for 75 per cent. Hon. Ngunzi: Mr. Speaker, as it is the norm of the Members of this House, I gave them the copies of the report but I know they are safe in their drawers and those who are not here today may not actually know what was debated in the House. I do not want to lose Mr. Speaker; allow me to defer this report for a better day, with your leave, Sir.

Hon. Speaker: Okay. Let me hear Hon. Mueni.

Hon. (Ms.) Mueni: I do not think whether there is anything wrong with reading the report because there is nobody who does not know about this motion. Everybody knows the answer and whatever, so by saying that there is no quorum---

Hon. Katela: Point of order

Hon. (Ms.) Mueni: Protect me, Mr. Speaker, Sir.

Hon. Speaker: Let me take the point of order.

POINT OF ORDER

Hon. Katela: Mr. Speaker, Sir, with all due respect, I support the reading of the motion but as the Chairperson or the presenter of the motion has put it, this is a matter which has interest of many Members of this House and please Mr. Speaker with your leave, if you could allow him, we have at least a bigger number even if it is tomorrow, Mr. Speaker, that would be good because we want every Member to participate in this which will be a lesson to other officers who might choose to take the routeof the Mulee person. Thank you, Mr. Speaker.

Hon. Speaker: Hon. Katela, you are out of order when you impute guilt on an officer when a report has not yet been deliberated. Let us hear Hon. Chairperson, Legal.

Hon. Itumo: Mr. Speaker, I do not see the reason why the mover of this particular report....I smell a rat about the issue of quorum, Mr. Speaker. I feel that we should carry on and we go through the report; this is a report that we were issued with and we have gone through the report and we are ready. He thinks he has not lobbied enough of the rest of the Members to be in the House. Why should he just fear that he is going to lose, Mr. Speaker? Let him carry on and this is not a place to waste time; this is a Hon. House. Mr. Speaker, let us carry on with this report. Thank you, Mr. Speaker.

Hon. Speaker: Hon. Cecilia.

Hon. (Ms.) Sereka: Mr. Speaker, I think the mover of this motion knows very well that the Constitution gives a number of Members to be in and Mr. Speaker if you can look at how the House is, not even five Members of that Committee are here to even debate that motion. Mr. Speaker, I think it would be wise you give the mover of the motion time to organize himself because as you can see, he is not organized and even the vice Chairperson is not around. Mr. Speaker, please give him time; he needs time.

Hon. Speaker: Thank you, any other contribution? Hon. Members, the finding of the Speaker is that I find the request having basis for the reason that I am aware that there are Members of this House that are on official function in Kisumu and that this matter will be returned back to the House Business committee for further balloting.
