**THE MACHAKOS COUNTY APPROPRIATION
BILL, 2016**

A Bill for

AN ACT County Assembly of Machakos to authorize the issue of a sum of money out of the Machakos County Revenue Fund and its application towards the service of the year ending 30th June, 2017 and to appropriate that sum and a sum voted on account by county assembly for certain public services and purposes.

ENACTED by the County Assembly of Machakos, as follows—

1. This Act may be cited as the Machakos County Appropriation Act, 2016.

Short title

2. The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the services of the year ending on the 30th June, 2017, the sum of Kenya Shillings **Eleven Billion Two Hundred Ninety Six Million Three Hundred Sixty Two Thousand Fifty Five (KSh. 11,296,362,055)** and that sum shall be deemed to have been appropriated as from 1st July, 2016.

3. The sum granted by section 2 shall be appropriated for several services and purposes specified in the second column of the first schedule in amounts specified in the third column of that schedule.

MEMORANDUM OF OBJECTS AND REASONS

Clause 2 of this Bill provides for the issue out of Machakos County Revenue Fund, of the sum of Kenya Shillings 11,296,362,055 (Eleven Billion Two Hundred Ninety Six Million Three Hundred Sixty Two Thousand Fifty Five) required to meet public expenditure during the Financial Year ending 30th June 2017.

The clause also appropriates the money granted for the services and purpose specified in the schedule, which is based on the approved estimates for 2016/2017 Financial Year.
