9*MOTION – APPROVAL OF REPORT OF THE STATUS OF CONTRACTED RURAL**
ROADS PROJECTS FY 2022/2023

(Hon. Muoki Musila – Chairperson, Transport, Roads and Public Works)

Honorable Speaker, that aware that the County Assembly’s oversights function is one of the cornerstones of democracy; Aware that oversight is a means for holding the County executive accountable for its actions and for ensuring that it implements policies in accordance with the laws and budget passed by the County Assembly;

Acknowledging that Article 183(3) of the Constitution of Kenya, 2010 provides that the County Executive Committee shall provide the County Assembly with full and regular reports on matters relating to the County; further aware that Article 185(3) states that the County Assembly while respecting the principle of separation of powers, may exercise oversight over the County Executive Committee and any other County Executive Organs;

Cognizant that the Transport, Roads and Public Works Committee is established under second Schedule Standing Order 190 and is mandated to deal with all matters related to county transport, including county

roads; Aware that the Transport, Roads and Public Works Committee received report on status of rural roads projects from the Department of Roads and Transport, conducted several site visits to ascertain the status of the sampled roads as indicated in the report, held meetings with the County Executive Committee Member and compiled this report;

Honorable Speaker, I wish to move the Motion **THAT**, this Honorable House discusses and approves the Transport, Roads and Public Works Committee report on the status of contracted Rural Roads Projects FY 2022/2023.

10*MOTION – ALTERATION OF THE ASSEMBLY CALENDAR AND ADJOURNMENT OF THE HOUSE**

Honorable Speaker, that aware that the second Session of the Third Assembly commenced on 14th February, 2023; further aware that pursuant to Standing Order No. 25 (1), the Assembly approved an Assembly calendar on 14th March, 2023 and altered it on 15th March, 26th April and 13th June, 2023 through House resolutions;

Aware that Standing Order 24(1) provides that except for the session commencing immediately after a general election, the regular sessions of the Assembly shall commence on the Second Tuesday of February and terminate on the first Wednesday of December; Further aware that the House is scheduled to adjourn for its long recess on Wednesday 6th December, 2023 as per the approved Assembly Calendar;

Acknowledging that Standing Order 25(4) provides that despite the adjournment date as scheduled in the approved Assembly Calendar, the Assembly may by resolution, alter its Calendar or the adjournment date; Aware that members have been invited to participate in the National Kenya Music and Cultural Festival in Makueni County from 30th November to 10th December, 2023;
