FOREWORD

Pursuant to Regulation 9 (3) of the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019, the County Executive Committee Member (CECM), Education and Social Services nominated the following persons for appointment to the County Bursary Committee:

1. Anthony Munyao Kitungi - Nominee for the position of Chairperson.
2. Anna Ndunge Munyao - Woman nominee representing persons with disabilities.
3. John Muthoka - Man nominee representing persons with disabilities.
4. Rev. Joseph Nzola - Man nominee representing faith based organizations.
5. Justina Mumo Stephen - Woman nominee representing faith based organizations.
6. Robert Musyoka - Man nominee representing the youth.
7. Carolyne Mutanu Kimanthi - Woman nominee representing the youth.
8. Darrick Mutunga Mutilu - Man nominee with experience in Public Administration.
9. Dorris Munyaanyi Mang'ea - Woman nominee with experience in Public Administration

Notification of the nominations was conveyed to the Clerk of the County Assembly through letter Ref. No. GMC/21/DOEE/CO/OOG/VOL.11/34 dated 14th November, 2024 for nine (9) nominees for appointment as Chairperson and Members of County Bursary Committee following expiry of term of the previous committee.

On Tuesday, 19th November, 2024, the Speaker of the County Assembly read the message from the CECM, Education and social services communicating the names of the nominees. Further, pursuant to Section 7(1) of the Public Appointments (County Assemblies Approval) Act, 2017 and Standing Order 42(2) and 190 (5) (f), the names of the nominees were committed to the Education and Social Services Committee for approval hearings and reporting to the House within twenty one days.

Consequently, and in accordance with Article 196(1) of the Constitution, Section 7(5) and (10) of the Public Appointments (County Assemblies Approval) Act, 2017 and Standing Order 42(5) and (6), the Clerk of the County Assembly placed an advertisement in the print media on Wednesday, 20th November, 2024 inviting the public to attend the approval hearings and/or submit any information or comments on suitability or otherwise for appointment of the nominees. The submissions were to be way of sworn affidavits or hand-delivered to the Office of the Clerk of the Assembly. By close of the submission deadline, the committee had not received any memoranda touching on the suitability of the nominees for appointment. In the same

advertisement, the Clerk of the County Assembly notified the public that the Education and Social Services would conduct the approval hearings on Tuesday, 26th November, 2024 at the County Assembly Boardroom 4A.

The nominees appeared before the Committee as scheduled for approval hearings in accordance with the provisions of the Constitution, the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019, Public Appointments (County Assemblies Approval) Act, 2017 and the County Assembly of Machakos Standing Orders.

Pursuant to Section 7(8) and (9) and Section 8 of the Public Appointments (County Assemblies Approval) Act, 2017, the Committee observed that the nominees met the requirements of Chapter Six of the Constitution, demonstrated knowledge on the role of the County Bursary Committee and had the requisite experience and qualifications.

The nominees scored above the pass mark of 60 per cent set by the Committee to be approved for appointment as members of the County Bursary Committee. The nominees are:

1. Anthony Munyao Kitungi as Chairperson of the County Bursary Committee (average mark of 94 per cent).
2. Anna Ndunge Munyao as a Woman member of the County Bursary Committee representing Persons with disability (PWD) (average mark of 88 per cent).
3. John Muthoka as a Man member of the County Bursary Committee representing PWD (average mark of 74 per cent).
4. Rev. Joseph Nzola as a Man member of the County Bursary Committee representing faith based organizations (average mark of 71 per cent).
5. Justina Mumo Stephen as a Woman member of the County Bursary Committee representing faith based organizations (average mark of 86 per cent).
6. Robert Musyoka as a Man member of the County Bursary Committee representing the youth (average mark of 81 per cent).
7. Carolyne Mutanu Kimanathi as a Woman member of the County Bursary Committee representing the youth (average mark of 88 per cent)
8. Darrick Mutunga as a Man member of the County Bursary Committee with experience in public administration (average mark of 89 per cent).
9. Dorris Munyaanyi Mang'ea as a Woman member of the County Bursary Committee with experience in public administration (average mark of 91 per cent)

Having conducted the approval hearings for the nominees pursuant to Regulation 9(3) of the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019, Sections 4

and 9 of the Public Appointments (County Assemblies Approval) Act, 2017 and Standing Order 190(5)(f), the Committee recommends that the House:

1. Approves the nomination of Antony Munyao Kitungi for appointment as Chairperson of the County Bursary Committee by the CECM, Education.
2. Approves the nomination of Anna Ndunge Munyao as a Woman member representing PWD, to the County Bursary Committee by the CECM, Education.
3. Approves the nomination of John Muthoka as a Man member representing PWD to the County Bursary Committee by the CECM, Education.
4. Approves the nomination of Rev. Joseph Nzola as a Man member representing faith based organizations to the County Bursary Committee by the CECM, Education.
5. Approves the nomination of Justina Mumo Stephen as a Woman member representing faith based organizations to the County Bursary Committee by the CECM, Education.
6. Approves the nomination of Robert Musyoka as a Man member representing the youth to the County Bursary Committee by the CECM, Education.
7. Approves the nomination of Carolyne Mutanu Kimanthi as a Woman member representing the youth to the County Bursary Committee by the CECM, Education.
8. Approves the nomination of Darrick Mutunga as a Man member with experience in public administration to the County Bursary Committee, by the CECM, Education.
9. Approves the nomination of Dorris Munyaanyi Mang'ea as a Woman member with experience in public administration to the County Bursary Committee by the CECM, Education.

The Committee is appreciative to the Offices of the Speaker and the Clerk of the County Assembly for the support accorded during the exercise. I wish to also express my appreciation to the Honorable Members of the Committee for their dedication and participation in this exercise.

1.0 PREFACE

1.1 Establishment and Mandate of the Committee

1. Section 14(3)(a) of the County Governments Act, 2012 provides that when the Assembly is considering any appointment for which its approval is required under the Constitution, an Act of Parliament or county legislation, the appointment shall be considered first by a committee of the County Assembly.
2. The establishment and mandate of the Education and Social Services Committee is provided for under Standing Order 190 and second schedule of Machakos County Assembly Standing Orders.

2.0 BACKGROUND

2.1 Notification of Nominations

5. Pursuant to Section Regulation 9(3) of the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019 read with Section 4 and Section 6(1) of the Public Appointments (County Assemblies Approval) Act, the County Executive Committee Member (CECM) in charge of the County Department of Education forwarded to the Clerk of the County Assembly a letter dated 25th October, 2024 (*Annexure 1*) forwarding names of six (6) persons nominated for appointment as members of the Machakos County Bursary Committee for a period of three (3) years.
6. On Committal to the Education and Social Services Committee and upon scrutiny it was established that the list had not complied with Regulation 9 (2) of the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019 which provides that the County Bursary Committee shall consist of the Chairperson and eight (8) other members representing various sectors of the society. Consequently the committee requested for additional information from the CECM vide letter Ref. MKSCA/PCS/CMM/ESW/VOL.5/2 (*Annexure 2*) dated 12th November, 2024.
7. In response, the CECM in a letter Ref. GMC/21/DOEE/CO/OOG/VOL.11/34 (*Annexure 3*) dated 14th November, 2024 wrote to the Clerk of the County Assembly recalling the earlier list and forwarding a list of nine (9) nominees for vetting and approval by the County Assembly for the positions of Machakos County Bursary Committee. The list was tabled before the House on 19th November, 2024 and pursuant to Section 7(1) of the Public Appointments (County Assemblies Approval) Act, 2017 and Standing Order 42 (2) and 190 (5) (f), committed to the Education and Social Services committee for approval hearings and reporting to the House within twenty one days. The nominees are:
 - 1). Anthony Munyao Kitungi - Nominee for the position of Chairperson.
 - 2). Anna Ndunge Munya - Woman nominee representing persons with disabilities.
 - 3). John Muthoka - Man nominee representing persons with disabilities.
 - 4). Rev. Joseph Nzola - Man nominee representing faith based organizations.
 - 5). Justina Mumo Stephen - Woman nominee representing faith based organizations.
 - 6). Robert Musyoka - Man nominee representing the youth.
 - 7). Carolyne Mutanu Kimanathi - Woman nominee representing the youth.
 - 8). Darrick Mutunga Mutilu - Man nominee with experience in Public Administration.
 - 9). Dorris Munyaanyi Mang'ea - Woman nominee with experience, Public Administration

2.2 Notification to the Public

8. Article 196(1) of the Constitution provides that a County Assembly shall:

(a) Conduct its business in an open manner and hold its sittings and those of its committees, in public; and

(b) Facilitate public participation and involvement in the legislative and other business of the assembly and its committees.

9. Section 7(5) of the Public Appointments (County Assemblies Approval) Act, 2017 provides that the committee shall, by notice in at least one newspaper of national circulation, notify the public of the time and place for holding an approval hearing at least seven days prior to the hearing. Further, Section 7(10) of the same Act provides that any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk of the County Assembly with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated.

10. Pursuant to Article 196(1) of the Constitution as read with Section 7(5) and (10) of the Public Appointments (County Assemblies Approval) Act, 2017 and Standing Order 42(5) and (6), the Clerk of the County Assembly placed an advertisement in the print media on Wednesday, 20th November, 2024 (*Annexure 4*) inviting the public to attend the approval hearing and/or submit any information or comments on suitability or otherwise by way of sworn affidavit(s).

11. The advertisement indicated that submissions were to be received in the Office of the Clerk of the County Assembly on or before Monday 25th November, 2024. In addition, the advertisement notified the public that the approval hearings of the nominees would be conducted on Tuesday, 26th November, 2024 at the County Assembly Boardroom 4A.

2.3 Notification to the Nominees

12. On Wednesday, 20th November, 2024, the Clerk of the County Assembly invited the nominees in writing and through print media, for the approval hearings in accordance with Section 7(4) of the Public Appointments (County Assemblies Approval) Act, 2017.

2.4 Clearance and Compliance Requirements

13. Pursuant to Section 4(2) and (4) and Section 44(2) of the Leadership and Integrity Act, 2012, the Clerk forwarded the names of the nominees to the Ethics and Anti-Corruption Commission (EACC) via letters Ref. MKSCA/ADM/VETT/VOL.3/50 dated 28th November 2024 and folio 52 dated 3rd December, 2024 (*Annexure 5*) for verification on compliance with Chapter Six of the Constitution.

2.5 Issues for Consideration during the Approval Hearings

14. Sections 7(8) and (9) of the Public Appointments (County Assemblies Approval) Act, 2017 provides that:

(8) An approval hearing shall focus on a candidate's academic credentials, professional training and experience, personal integrity and background.

(9) The criteria specified in the First Schedule and the assessment form specified in the Second Schedule shall be used by a committee during an approval hearing for the purposes of vetting a candidate.

15. Further, Section 8 of the Public Appointments (County Assemblies Approval) Act, 2017 provides that the issues for consideration by the relevant County Assembly in relation to any nomination shall be:

(a) The procedure used to arrive at the nominee including the criteria for the shortlisting of the nominees;

(b) Any constitutional or statutory requirements relating to the office in question; and

(c) The suitability of the nominee for the appointment proposed having regard to whether the nominee's credentials, abilities, experience and qualities meet the needs of the body to which the nomination is being made.

16. During the approval hearings, the Committee was guided by the provisions of Section 7(8) and (9) and Section 8 of the Public Appointments (County Assemblies Approval) Act, 2017.

2.5.1 Procedure for Nomination

17. Section 6(1) of the Public Appointments (County Assemblies Approval) Act, 2017 requires the appointing authority, upon nominating a person for appointment, to notify the relevant County Assembly accordingly. In this regard and pursuant to Regulation 9(3) of the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019 and Section 6(1) of the Public Appointments (County Assemblies Approval) Act, 2017, the CECM notified the Assembly of the nomination of nine (9) persons for appointment as Chairperson and Members of the County Bursary Committee.

2.5.2 Constitutional and Statutory Requirements

18. The Constitution and the County Governments Act, 2012 provides for guidelines on how to appoint persons to public office. The committee in determining suitability of the nominees was guided by the provisions on leadership and integrity as outlined under Chapter Six of the Constitution and Regulation 9 (2) of the Public Finance Management

2.5.3 Suitability of the nominees

19. The suitability of the nominees was assessed after scrutiny of their academic credentials, professional training and experience, personal integrity, background and qualities as well as their performance during the approval hearings conducted on Tuesday, 26th November, 2024.

2.6 Consideration of memoranda from Members of the Public

20. Section 7(10) of the Public Appointments (County Assemblies Approval) Act, 2017 provides that *“any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated.”*
21. Accordingly, the Clerk of the County Assembly placed an advertisement in the print media on 20th November, 2024 (*Annexure 4*) inviting the public to submit any information or comments on suitability or otherwise of the nominees in conformity with Section 7(10) of the Public Appointments (County Assemblies Approval) Act, 2017. By Monday, 25th November, 2024, which was the deadline of submission, the County Assembly had not received any sworn statements contesting suitability of any of the nominees.

3.0 APPROVAL HEARINGS

22. The Committee held sittings on 12th, 19th and 25th November, 2024 to deliberate on the approval hearings and noted the following:
 - (i) **THAT**, Regulation 9 (2) of the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019 provides that the CECM, in nominating members to the County Bursary Committee shall nominate the Chairperson, a woman and a man representing faith based organizations, the youth, PWD and persons with experience in public administration, public affairs or management.
 - (ii) **THAT**, the Committee would examine the nominees based on the criteria set out in Section 7(9) of the Public Appointments (County Assemblies Approval) Act, 2017.
 - (iii) **THAT**, the Committee would use the assessment form provided in the Second Schedule of the Public Appointments (County Assemblies Approval) Act, 2017 with necessary modifications in line with the requirements set out in Regulation 9 (2) of the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019 and that the pass mark for each would be sixty (60) per cent.
 - (iv) **THAT**, none of the nominees had notified the Clerk of the County Assembly of their

withdrawal from the vetting process as outlined under Section 7(12) of the Public Appointments (County Assemblies Approval) Act, 2017 and the Committee would therefore proceed with the approval hearings on Tuesday, 26th November, 2024.

23. The approval hearings proceeded as scheduled.

3.1 MR. ANTHONY MUNYAO KITUNGI, NOMINEE CHAIRPERSON COUNTY

BURSARY COMMITTEE

24. The nominee appeared before the Committee on Tuesday 26th November, 2024 at 9.30a.m and was vetted under oath pursuant to the Public Appointments (County Assemblies Approval) Act, 2017, the Public Finance Management (Machakos County Bursary Fund) Regulations, 2019 and the County Assembly Standing Orders. The Committee noted the following:

Place of residence

25. The nominee is a residence of Mavoko sub-county in Machakos County.

Academic and Professional Qualification

26. The nominee holds a Master of Business Administration degree from Daystar University, 2011 and a Bachelor of Education degree from Moi University, 1992.

Work Experience

27. The nominee is currently serving as the principal Kwanthanze high school. He has also served as a principal at St. Augustine Mlolongo high school from 2007 to 2018 and as a deputy principal and a teacher in various schools.

Income and Net worth

28. The nominee stated that his net worth is Ksh. 15 million with his source of income being salary, rent and farming.

Professional associations and membership

29. The nominee stated that he is the Chairperson, Kenya Secondary School Heads Association (KSSHA) Machakos County. He is also the Chairperson KSSHA, Athiriver Sub-County and a member of ministry of education bursary committee Kathiani constituency.

Honors and Awards

30. The nominee did not declare any honors or award.

Potential Conflict of Interest

31. The nominee did not declare any potential conflict of interest.

Pro Bono/ Charity Work

32. The nominee did not indicate any Pro Bono/Charity Work.

Integrity

33. The nominee submitted the following clearance certificates:

- (i) Self-declaration form from EACC dated 25th November, 2024.
- (ii) Certificate of clearance from the Credit info dated 19th November, 2024 indicating no negative listing.
- (iii) HELB clearance certificate dated 18th January, 2005 indicating completion of loan repayment.
- (iv) Tax Compliance Certificate from KRA dated 24th June, 2015
- (v) Certificate of good conduct from the DCI dated 20th November, 2024.

3.1.1 General and Specific Questions to the Nominee

Equity, Transparency and Inclusivity in Bursary Disbursement

34. Asked about how he would ensure equity, transparency and inclusivity in bursary disbursement, the nominee stated that he would follow the policy guidelines as laid down and that he would ensure that bursaries are purely issued on need basis.

Challenges faced during bursary disbursement

35. The nominee stated that one challenge he has faced during bursary disbursement is multiple allocations of bursaries to one beneficiary where some parents demand for a refund for the excess amount paid to the school.

Stakeholders' involvement

36. Asked how he would bridge the relevant stakeholders when administering bursaries so as to solve conflicts that usually arise, the nominee responded that in conjunction with the Committee and the department of Education he would seek to capacity build the public on the bursary disbursement process.

County Bursary Committee Sector Representation

37. Asked if he was aware of the sector representation in the bursary Committee and the importance of this representation, the nominee mentioned that he was aware of the PWD, the Clergy, and Educationists. He mentioned that the MCAs are critical stakeholders.

Chapter Six of the Constitution

38. Asked on whether he was aware of the provisions of Chapter six of the Constitution of Kenya, the nominee confirmed that he was aware and stated that it provides for the code of ethics fairness and transparency. He further highlighted that he had no integrity issues.

3.1.2 Committee Observations on the Suitability of the Nominee

The nominee was also nominated to represent Mwala Constituency during the 1st National women League on HIV and AIDS in 2004. She was also awarded a certificate of appreciation for

actively participating in ICT mentors induction training in 2013 by Ministry of Education, Mwala District.

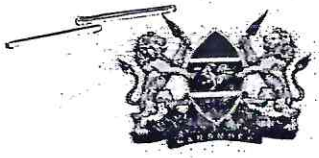

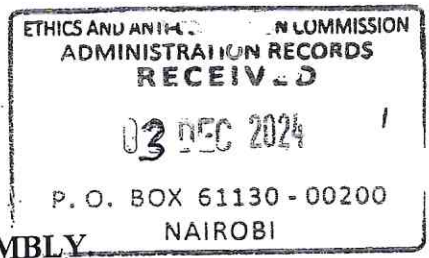



Dire Ongoing shortages of food and medicine are causing widespread hunger and suffering Hamas to protect aid convoys

Fighters and other Gaza factions have now formed an armed force to prevent gangs pillaging relief vehicles

CAIRO, TUESDAY

Fighters from Hamas and other Gaza factions have formed an armed force to prevent gangs pillaging aid convoys in the embattled territory, residents and sources close to the group said, after a big increase in the looting of scarce supplies.

Since being formed this month amid rising public anger at aid seizures and price gouging, the new force has staged repeated operations, ambushing looters and killing some in armed clashes, the sources said.

Hamas' efforts to take a lead in securing aid supplies point to the difficulties Israel will face in a post-war Gaza, with few obvious alternatives to a group it has

been trying to destroy for over a year and which it says can have no governing role.

Israel accuses Hamas of hijacking aid. The group denies that and accuses Israel of trying to foment anarchy in Gaza by targeting police guarding aid convoys.

A spokesperson for Israel's military did not immediately respond to Reuters' request for comment on Hamas units fighting looters. Amid the chaos of the war, armed gangs have increasingly raided supply convoys, hijacking trucks and selling the looted stock in Gaza markets at exorbitant prices.

As well as driving anger at the Israeli military, the shortages had also prompted questions of Hamas for its seeming inability to

stop the gangs.

"We are all against the bandits and looters so we can live and eat... now you are obliged to buy from a thief," said Diyaa al-Nasara, speaking near a funeral for a Hamas fighter killed in clashes with looters.

The new anti-looting force, formed of well-equipped fighters from Hamas and allied groups, has been named "The Popular and Revolutionary Committees" and is ready to open fire on hijackers who do not surrender, one of the sources, a Hamas government official, said.

The official, who declined to be named because Hamas would not authorise him to speak about it, said the group operated across central and southern Gaza and

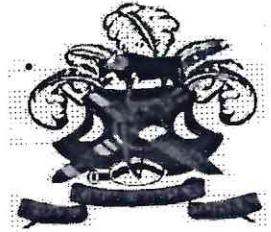

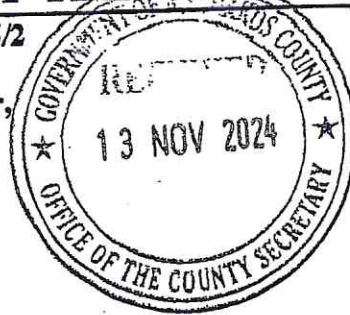
